Thank you for your recent Freedom of Information Request.

I am now able to provide you with the information supplied by the relevant department, as follows:

Nottinghamshire County Council as the second tier authority is the Minerals and Waste Local Authority and therefore develops the Waste and Minerals Local Plan for the whole of Nottinghamshire.

The current adopted plans include the Nottinghamshire and Nottingham Waste Core Strategy, which was adopted in December 2013, and the Nottinghamshire Minerals Local Plan, which was adopted in December 2005. The links for these documents are below:

A new Minerals Local Plan is currently being prepared, with a Draft Plan published for consultation in July 2018. Following this, it is expected that a Publication Version will be consulted upon in September 2019 and submitted for examination in January 2020, expecting adoption in September 2020.

In terms for the Waste Plan, a revised Joint Waste Local Plan (incorporating a review of Waste Core Strategy) is also in preparation. Consultation on scope, issues and options is expected in November 2019, with adoption of new plan expected in November 2021.
