# What Happens Next

The registration of debt is an automated process and there is no right of personal representation during this process. When the debt is registered at the County Court against you a warrant may subsequently be issued for the recovery of the debt by Enforcement Agents. You will also become liable for Court and Enforcement Agents fees.
