**To increase the school's net capacity by expanding the school's existing premises.**

**School capacity:**

5. (a) Details of the current capacity of the school and, where the proposals will alter the capacity of the school, the proposed capacity of the school after the alteration.

**NCC proposes to make a prescribed alteration to Heatherley Primary School by expanding the school's current net capacity from 210 permanent places to 315 from September 2015.**

- (b) Details of the current number of pupils admitted to the school in each relevant age group, and where this number is to change, the proposed number of pupils to be admitted in each relevant age group in the first school year in which the proposals will have been implemented.

**It is intended that the number of pupils to be admitted into the first age group of the main school (Planned Admission Number) will increase from 30 to 45 from September 2015, subject to annual consultation on admissions arrangements.**

- (c) Details of the current number of pupils on roll at the school at the time of the publication of the proposal.

**At the time of publication, there were 220 full-time equivalent pupils on roll at the school.**

**Objectives:**

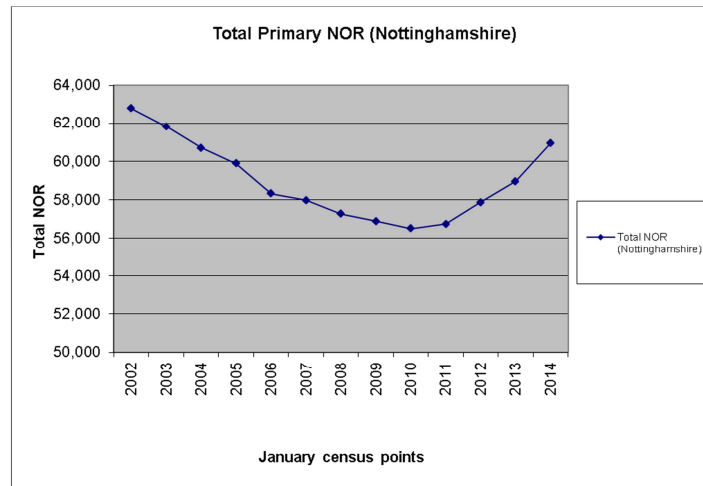
**The objective of the expansion proposal is to meet basic need within the Forest Town area. There is insufficient capacity at the sites of local schools in the area for the projected level of demand. It is anticipated that by expanding a popular school the expertise of leadership, management and curriculum delivery will ensure provision of excellent quality school places.**

**Evidence of Demand:**

8. Evidence of demand for the additional school places.

**In line with the underlying national trend, Nottinghamshire has seen an increase in birth rates across the county since 2007. This is reflected in the overall school population but is particularly well illustrated in the numbers of primary age children (Figure 1).**

**The total primary Number on Roll (NOR) had seen a steady decline in numbers between 2001 and 2010 but subsequent years have seen a sharp increase in total numbers to the school year 2013/14.**



**Figure 1 - Total number on roll in mainstream primary schools**

**The numbers of primary aged pupils have increased across Forest Town and the expansion of Heatherley Primary is required to meet an increasing basic need for pupil places within the school's area.**

**Without the places being made available at Heatherley Primary, the County Council will not be able to offer school places for all children living in the area within a reasonable distance to their homes.**

**Effect of Proposal:**

**Project costs:**

**It is intended that the gross costs for developing Heatherley Primary will be secured from NCC's Basic Need Programme.**

**Long term value for money will be achieved by the provision of permanent additional accommodation.**
