Further to your recent request for information under the freedom of information act, please see Nottinghamshire county Councils response.

It is not possible for the LA to supply accurate information on pathology testing due to STI testing being part of a tariff that includes a medical consultation or postal costs if via an on line service.

Your FOI is seeking laboratory costs i.e. testing for STIs however the service we have includes the cost of posting the kit, the testing kit itself and returning the kit in free post for the citizen. So the lab costs are within this and not possible to separate out. We also commission an Integrated Sexual Health Service from three NHS Trusts and pay all other Trusts national a STI testing costs but these are covered in a tariff so are not solely Lab costs

The spend for the three years on the service costs in relation to STIs via our On Line STI testing are:
