

The Nottinghamshire County Council (Alverton, Aslockton, Balderton, Cotham, Elton on the Hill, Flawborough, Kilvington, Orston, Shelton, Staunton in the Vale and Thoroton, Nottinghamshire) (Weight Restriction) Experimental Order 2012 (3176)

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under Section 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and with the consent of the Secretary of State under Part II of Schedule 9 and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule to the Act hereby makes the following Order:-

1. Save as provided in Article 2 of this Order, no heavy commercial vehicle shall, except upon the direction or with the permission of a Police Constable in uniform, to proceed in any of the roads specified in Schedule 1 to this Order.
2. Nothing in Article 1 of this Order shall make it unlawful for a heavy commercial vehicle to proceed in the roads specified in Schedule 1 to this Order if the vehicle is being used:-
 - (1) for or in connection with the conveyance of goods to or from premises situated on or adjacent to that length of road;
 - (2) for the purpose of agriculture on any land adjacent to that length of road or for or in connection with the conveyance or haulage of timber felled upon such land;
 - (3) in connection with the carrying out on, or on the premises situated on or adjacent to, that length of road of any of the following operations, namely –
 - (i) building, industrial or demolition operations;
 - (ii) the removal of obstructions to traffic;
 - (iii) the maintenance, improvement or reconstruction of the road;
 - (iv) the laying, erection or alteration or repair in, or in land adjacent to the road, of any sewer or any main, pipe or apparatus for the supply of water, gas, electricity or any

telegraphic line as defined in the Telecommunications Act 1984;

- (v) for fire brigade, police or ambulance purposes;
- (vi) to proceed from any premises which are situated on or adjacent to that length of road and at which the vehicle is to be, or has been garaged, serviced or repaired;
- (vii) in the service of local authority or water authority in pursuance of statutory powers or duties;
- (viii) in connection with a circus, fair or similar event, the holding of which on, or in the vicinity of, that length of road has been authorised by the Council;
- (ix) on that road for or in connection with the conveyance of goods for sale from the vehicle;
- (x) to gain access to land or premises, which access is obtained only by proceeding along the length of road referred to in the said Article 1.

3. The Council are satisfied that for preserving or improving amenities by restricting the use on the roads referred to in Article 1 of this Order, of goods vehicles, it is requisite that Section 3(1) of the Act should not apply in relation to this Order.

4. (a) Revocation of Length

Where, in Schedule 2 this Order

- (i) an Order is specified and
- (ii) a length of road is specified in respect of that Order and
- (iii) no provision is specified in relation to that length of road:-

the effects of that Order are revoked insofar as it relates to that length of road.

(b) Revocation of Provision

Where in Schedule 3 to Part V of this Order

- (i) an Order is specified and
- (ii) a length of road is specified in respect of that Order and
- (iii) a provision is specified in relation to that length of road:-

the effects of such provision of that Order are revoked insofar as the provision relates to that length of road.

5. In this Order "heavy commercial vehicle" has the same meaning as that ascribed to it in Section 138 of the Act.
6. This Order may be cited as "The Nottinghamshire County Council (Alverton, Aslockton, Balderton, Cotham, Elton on the Hill, Flawborough, Kilvington, Orston, Shelton, Staunton in the Vale and Thoroton, Nottinghamshire) (Weight Restriction) Experimental Order 2012" and shall come into force for all purposes on the **6th** day of **April 2012** and shall continue in full force to the **5th** day of **October 2013** inclusive.

SCHEDULE 1

Road at Orston in the Borough of Rushcliffe

- (a) C3 Station Road, Lordship Lane, Spa Lane, Longhedge Lane, Newark Road, Alverton Road, Staunton Road and Grange Lane, between its junctions with The A52 Trunk Road and Staple Lane.

Road at Aslockton, Orston and Thoroton in the Borough of Rushcliffe

- (b) C112 Smite Lane, The Green and Longbon, between its junctions with C58 Cliffhill Lane and Mill Lane.

Road at Orston in the Borough of Rushcliffe

- (c) Mill Lane, between its junctions with Hill Road and Longhedge Lane.

Road at Orston in the Borough of Rushcliffe

- (d) Spa Lane, between its junctions with Mill Lane and C3 Lordship Lane.

Road at Orston in the Borough of Rushcliffe

- (e) Hill Road, between its junctions with Mill Lane and C3 Station Road.

Road at Flawborough, Orston and Thoroton in the Borough of Rushcliffe

- (f) C102 Longhedge Lane, Main Road and Alverton Road, between its junctions with C58 Shelton Road (Thoroton) and C3 Newark Road.

Road at Cotham in the District of Newark and Sherwood and Sheldon in the Borough of Rushcliffe

- (g) C59 Station Road (Cotham), Cotham-Wensor Bridge Road and Wensor Bridge Road, between its junctions with C3 Grange Lane and C58 Elston Road.

Road at Cotham in the District of Newark and Sherwood

- (h) The Cotham-Wensor Bridge Road, between its junctions with C59 Station Road and C100 Main Street.

Road at Cotham and Hawton in the District of Newark and Sherwood

- (i) C100 Main Street, Grange Lane Road, Main Street (Cotham), Cotham Road, Newark Road and Hawton Road, from its junction with C3 Grange Lane to a point 67 metres south of its junction with Riverside Road.

Road at Orston in the Borough of Rushcliffe

- (j) Bottesford Lane, from its junction with C3 Lordship Lane to the county boundary.

Road at Orston in the Borough of Rushcliffe

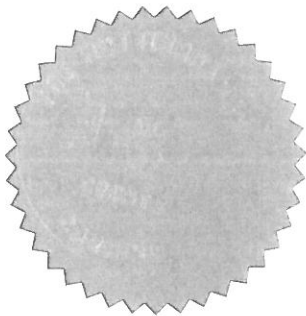
- (k) Longhedge Lane, from its junction C3 Spa Lane to the county boundary.

SCHEDULE 2

The Leicestershire County Council (Prohibition of Commercial Vehicles over 7.5T) (Various Parishes) (Northern Division) Order 1990 (Amendment 21) (Counties of Leicestershire, Lincolnshire, Nottinghamshire and Parish of Bottesford) Order 2006

1. BOTTESFORD LANE – Weight Restriction
from its junction with C3 Lordship Lane to the county boundary.
2. LONGHEDGE LANE – Weight Restriction
from its junction with C3 Spa Lane to the county boundary.
3. NEW ROAD – Weight Restriction
from its junction with C3 Grange Lane for a distance of 40 metres in an easterly direction.
4. VALLEY LANE – Weight Restriction
from its junction with C3 Staunton Road to the county boundary.
