- > Can you please provide all correspondence, letters, emails, minutes and agendas for all matters relating to East Leake school places and planning in the last 3 years.

- > The admission criteria in relation to twins into Brookside Primary School for the 2020-21 school year and whether one set of twins has been counted as 2 pupil places as per The School Admissions (Infant Class Sizes) (England) Regulations 2012 in relation to twins being excepted pupils. Brookside Primary School became an academy on 1 March 2020. At the time the admission arrangements for 2020-2021 were determined the school was a community school. Nottinghamshire County Council's determined admission arrangements for community and voluntary controlled schools 2020-2021 state that

"Multiple births (twins, triplets etc) Where one child of a multiple birth can be admitted through the normal admissions process, the other child/children will also be admitted."

Paragraph 2.15 of the School Admissions Code 2014 States that "Infant classes (those where the majority of children will reach the age of 5, 6 or 7 during the school year) must not contain more than 30 pupils with a single school teacher. Additional children may be admitted under limited exceptional circumstances. These children will remain an 'excepted pupil' for the time they are in an infant class or until the class numbers fall back to the current infant class size limit." The excepted children include "g) children whose twin or sibling from a multiple birth is admitted otherwise than as an excepted pupil;"

Twins or any siblings from a multiple birth are counted individually. They are only considered as permitted exceptions under Infant Class Size Regulations if one child of a multiple birth was admitted to the last place available, any siblings from the multiple birth could then be admitted as a permitted exception. As stated in the Code, if class sizes fall back to the current infant class size limit any child admitted as an excepted pupil ceases to be one.
