I am writing to you under the Freedom of Information Act 2000 to request the following information from Nottinghamshire County Council:

- The number of Council run secondary school teachers on long term sick leave due to mental health issues, as a breakdown of the last 5 years. ***As the number of Council run secondary schools in Nottinghamshire over the last 5 years has been low (ie 1), to provide the number of teachers on long term sick leave due to mental health issues would allow for those individuals to be identifiable and therefore should not be released.***
- The cost of the above.

- The number of Council run primary school teachers on long term sick leave due to mental health issues, as a breakdown of the last 5 years.
In order to obtain complete information, the requestor will need to ask each primary school direct as the authority only holds information on the number of Council run primary schools that buy back our service and therefore the information will be incomplete and disproportionate.
