Please can you send me a copy of Nottinghamshire County Council's bid for the government's COVID-19 Emergency Active Travel Fund.

The Councils Response is as follows:

The following has been extracted from the Emergency Active Travel Fund tranche 1 bid.

Please provide a brief summary of the scheme(s) or programme. For example, locations, measures to be adopted, whether they are permanent or temporary measures, and how the scheme or programme will improve mobility, and/or assist with social distancing. The programme is made up of a number of elements:

- Introduction of temporary vehicle access restrictions in four town centres to allow the use of the carriageway for pedestrians and cyclists and help enable social distancing in areas with high footfall
- Installation of permanent dropped kerb improvements in 10 towns/villages to enable people to access local shops and other key facilities on foot
- Temporary footway widening (e.g. creation temporary footways, removal of street furniture, suspension of on-street parking) in up to ten towns to help enable social distancing in areas with high

footfall

- Introduction of temporary segregated cycle lanes along key arterial routes into three towns to enable

people to make safer cycle journeys instead of public transport

- It should also be noted that the County Council is working with neighbouring Nottingham City on an additional route across Trent Bridge although it has not been possible to finalise these proposals within the timescales to complete this proforma
- Introduction of advisory 20mph speed limits in eight town centres to help encourage more walking and cycling within them
- Introduction of temporary traffic management measures (e.g. one-way traffic systems, traffic signals)

in three towns.

Note all of the above are still subject to the necessary detailed scheme investigation and design, consultation, safety audit and equality impact assessments which it has not been possible to complete in the limited time since the funding was announced on 9 May 2020. They will also be subject to the availability of the necessary materials required for their delivery.

£573,000 + VAT = £687,600
