Nottinghamshire County Council, in partnership with Nottingham and Derby city councils were awarded funding from the Office of Low Emission vehicles to help deliver a number of initiatives to promote and encourage ultra-low emission vehicles through the 'Go Ultra Low Nottingham' (GUL) programme (further information on this programme can be found at <http://goultralownottingham.org.uk/>).

23 public EV charging sites, across 17 towns in Nottinghamshire (Arnold, Barton in Fabis, Beeston, Carlton, Eastwood, Hucknall, Kimberley, Kirkby in Ashfield, Mansfield, Mapperley, Netherfield, Newark, Retford, Stapleford, Sutton in Ashfield, West Bridgford and Worksop).

All sites were installed and operational during 2019 and funded via the GUL programme.
