We are sorry on this occasion we wouldn't be able to currently answer the part of the question relating to weapons.

As possession of a weapon isn't one of the current 'reasons' for fixed term and permanent exclusions. The data we hold is against the following reasons:

Bullying
Damage
Drug and alcohol related
Other
Persistent disruptive behaviour
Physical assault against a pupil
Physical assault against an adult
Racist abuse
Sexual misconduct
Theft
Verbal abuse or threatening behaviour against a pupil Verbal abuse or threatening behaviour against an adult

For exclusions this academic year (2020/21) there are some new categories being introduced including 'Use or threat of use of an offensive weapon or prohibited item' so will be able to answer going forward.

We also wouldn't hold any information on the incident, this would be held at school level. You will need to contact the individual schools directly who may hold this data.

We trust this now resolves your enquiry and where we have not been able to provide details we expect that this information is not held by Nottinghamshire county Council at this time.

We suggest all requesters search under our publication scheme in advance of requesting information under the freedom of information act.
