We are unable to provide details pertaining to the safeguarding element of the request as this would require checking over 300 records at a minimum of 15-20 mins per record which would exceed the appropriate limit under s.12 of the Freedom of information Act and so we are applying this exemption at this time. You may wish to consider amending the request or reducing the size or type of information you require and we will look at this again for you.
