Introduction:

This consultation is concerned with the Dedicated Schools Grant Early Years Block. The Early Years Block is made up of funding for eligible 2 year olds, 3 and 4 year olds, supplementary funding streams for the most vulnerable. The hourly base rates are defined nationally, but the Local Authority has some discretion as to how the funding is distributed.

A separate consultation is being held for the 2023 -2024 Schools Local Funding formula.

Consultation is open until Monday 28th November 2022. Responses will be considered by the Early Years and Schools Forum on 8th December 2022.

Consultation Proposals on base rate funding - Background

Nationally, there is a Government consultation taking place to review the Early Years Funding Formulae and Maintained Nursery School Funding. The consultation closed on 16th September and the outcome is expected to be announced later in the Autumn. Government is not proposing changes to the overall quantum of funding going through the funding formulae, which remains at the level agreed at the Spending Review 2021. The consultation does, however, propose to update the formulae so that it is using the most up to date data available, and to continue to update the data annually going forward, to ensure that Government are distributing funding in line with current levels of need.

1. 3 and 4 year olds base rate

Early indications are that Nottinghamshire will remain on the minimum funding floor rate per hour allocated to the LA for every three and four year old which includes the (proposed) newly embedded elements of the TPPG mentioned below.

There are a number of options open to LAs dependent on the outcome of the National Consultation and as such, until guidance is received from Government, we are unable to finalise the hourly rate going forward, except to say that it is likely that Nottinghamshire will be able to continue to sustain the 5p uplift allocated in Autumn 2022.

2. Centrally retained funds

Local Authorities are permitted to retain up to 5% of monies allocated through the DSG to pay for central services. Nottinghamshire currently retains approximately 3.5% of the budget for this purpose.

3. Teachers Pay and Pensions Grant (TPPG)

The national consultation seeks views on the proposal to mainstream the early years elements of Techers Pay and Pension Grant funding, into the hourly rate for 3 and 4 year olds, bringing early years in line with schools and high needs. TPPG is currently paid to Schools in addition to the hourly rate in grant form. Guidance from the DfE is as follows: "We encourage local authorities to continue to use this funding to support some of the costs for which the grants were originally introduced... We would encourage LAs to consider using this supplement to take account of additional pressures that some providers might face, from the need to pay employer contributions to the teachers' pension scheme."

The rationale for this is that Since September 2019, the Employer contribution rate for Teachers¹ is 23.68%. This compares to the Workplace Contributions² of {minimum of} 3%. Schools would therefore be required to adjust budgets to make up a shortfall, should the TPPG be withdrawn.

Nottinghamshire therefore proposes to continue to ringfence the equivalent amount (from 2022-23) of TPPG for Early Years Provision in Schools and pay this as a grant calculated annually (should the national consultation result in an approval to mainstream the early years elements of Teachers Pay and Pension Grant funding, into the hourly rate).

Early Years Supplementary Funding 2023 - 2024

Background

Nottinghamshire County Council allocates a range of additional and supplementary funding to support early years entitlement places for eligible 2, 3 and 4 year olds who:

- are eligible for free school meals and meet the eligibility criteria on either economic grounds or are looked after by the local authority for **Early Years Pupil Premium**;
- are assessed as being in need under section 17 of the Children Act 1989, including children and young people who have a child in need plan, a child protection plan or who are a looked-after child and eligible for **Deprivation Funding**;
- have an education, health and care (EHC) plan and/or are eligible for EY Inclusion Funding;
- are in receipt of Disability Living Allowance and are eligible for DAF (Disability Access Funding).

Early Years Pupil Premium is currently paid at a rate of 60 pence per hour per eligible child and is funded alongside the hourly rate for three and four year olds. It is not proposed to make any changes to this arrangement.

5. Deprivation Fund:

It is proposed that some changes are made to the Deprivation Fund to enable the fund to be further targeted to those children who are in need of additional support. There are three options to be consulted on, all of which include a new element of funding to children who are not meeting expected levels of development in Communication and Language (C&L), as evidenced by provider EYFS data returns to Early Childhood Services which will be via 'Capita Better Start' and via 'Synergy' from 2023 onwards. This allows settings to identify children in need of early intervention who may not yet be a Child in Need, on a Protection Plan or Looked After.

A working party has already been consulted upon to come up with the three options below for wider consultation.

7. <u>Disability Access Fund (DAF)</u>: Is a one-off payment of £800 per year to support Children in receipt of Disability Living Allowance (DLA) to access provision and access their funded entitlements.

Definition of 'Access' and responsibility to make 'Reasonable Adjustments' (DAF Guidance March 2018) For the purpose of DAF and early years, access refers to:

- the means or opportunity to enter the provision of space where early education is to take place. This includes either domestic or non-domestic premises
- the means or opportunity to engage with the Early Years Foundation Stage with reference to the {seven} areas of learning and development and welfare requirements.

Substantial disadvantage can be avoided by making reasonable adjustments for disabled children. This means making positive steps to ensure that disabled children can fully participate in early education and enjoy the other benefits, facilities and services offered by the provision.

The reasonable adjustment duty comprises of three requirements:

- Provision, criteria and practices
- Auxiliary aids and services
- Physical features

DAF is allocated by the Education Schools Funding Authority based on the number of children in receipt of DLA assuming that they all attend a childcare setting and can claim DAF and as such, is generally poorly taken up. In order to fully utilise this funding, we propose to offer the following:

- Maintain the one off payments per annum to support settings to make physical adjustments to their provision (Remaining at £800 per annum)
- Development and update of the current materials used to promote DAF and access to childcare
- Increased opportunities for practice development and training linked to managing the needs of children with complex health needs and disabilities (to replace the training offer currently provided by the Inclusion Fund)
- Commission support for the most vulnerable children with complex emotional health needs.
