What are the aims of your proposed activity / policy? (Please keep to approximately 100 words.): As part of the Council's aim to continually improve service delivery and embed the principles of the Adult Social Care Strategy, there is a need to review the provision of registered residential care to ensure that the care and support provided is strengths based, maintains, or increases people's independence, reflects best practice and that people are supported in an environment that best meets their needs.

The Joint Carers Strategy 2023/28 sets out the vision for supporting carers in the future. The overall aim is to enable unpaid carers to access the right support to enable them to maintain their caring role whilst having a life alongside caring. For short breaks services, there is a need for flexibility and adaptability that meet the needs of informal carers and prevents carer breakdown.

There are currently 3 Council provided short breaks units for adults, providing 32 respite care beds, mainly to adults with learning disabilities, with a total staffing establishment of 68.4 FTE care staff. Over the last few years, occupancy has reduced due to changes to our eligibility policy and an increase in people using direct payments or personal budgets to access other forms of short breaks support.

Short breaks provision has not been reviewed for many years; however, the publication of the Joint Carers Strategy gives an opportunity to review and improve our service offer in response to the feedback from carers.

Any new model of provision and/ or service offer will be in line with the principles of the Carers Strategy, reflect best practice, value for money and will be co-produced with people who use our services and their carers.
