What are the aims of your proposed activity / policy? (Please keep to approximately 100 words.):

There are currently two Community Infection Prevention and Control (CIPC) Section 75 arrangements for Nottinghamshire. These comprise a County service (excluding Bassetlaw) hosted by what was Nottingham and Nottinghamshire Clinical Commissioning Group (CCG) and a Bassetlaw service provided by (then) Bassetlaw CCG. The current arrangements end on 30 September 2023. The intention is to extend the current arrangements with Nottingham and Nottinghamshire Integrated Care Board (ICB) and use this opportunity to review the service and make any minor amendments to the service specification. A review of CIPC arrangements was undertaken in 2022 to analyse local need and understand future risks; that review would then inform the shape of the future service delivery. The strategic priority for the current re-commissioning process is to maintain an effective, safe CIPC resource for residential nursing and care homes for older people in Nottinghamshire, as well as those for adults with a learning disability. In addition, a wider range of settings have been identified by the CIPC review as requiring ad hoc, temporary support in responding to an outbreak if urgently needed.
