She also sits on the Planning committee for Newark and Sherwood District Council, but has not taken any part in discussions appertaining to the application.

# APPROVED PREMISES FOR CIVIL CEREMONIES

Mr Fisher introduced the report

### CHANGE IN ORDER OF BUSINESS

The Chairman informed members that Agenda item 7 on the agenda Retrospective use of the site for Recycling of inert materials and construction of a 5 metre high sound attenuation wall, Wigwam Lane, Hucknall was withdrawn following further recent discussion with the applicant.

### ERECTION OF THREE STOREY REPLACEMENT SCHOOL THE NEWARK ACADEMY LONDON ROAD NEW BALDERTON NEWARK

Mr Smith introduced the report and gave a slide presentation and highlighted issues regarding the new leisure centre approved by the District Council near to the site and the reprovision of sports facilities impacted by the proposals as part of wider aspirations to deliver a Sports Hub for Newark.

He also informed members that the financial implications should read

The unilateral undertaking would commit the County Council to provide a contribution capped in the sum of £1,000,000 towards the provision of a new athletics track and all-weather pitch at the Sports Hub. The contribution would be provided from The Schools Capital Programme, first reported to Full Council as part of the 2011/12 Budget Report in February 2011, and most recently approved as part of the 2014/15 Budget Report that went to Full Council on 27 February 2014.

In light of the above, committee were also appraised of the following revised Constitutional comments: Planning & Licensing Committee is the appropriate body to consider the content of this report. For the avoidance of doubt, the statement of Financial Implications added to the report confirms that the County Council has made budget provision in respect of the proposed unilateral undertaking; this is not a matter for Planning & Licensing Committee to take into account and is for information only.

Mr Smith responded to questions as follows:-

- Paragraph 120-122 set out the issues surrounding the issue of bats and confirms that the 'tests' under the Habitats Regulations are all met.
- The school can only successfully implement a travel plan with the cooperation with parents.
- The issues around road safety were assessed by the County Council's Road Safety Team, dealt with within the report at paragraph 91- 94 and this will be monitored.

# **RESOLVED 2014/038**

- That planning permission be granted for the purposes of Regulation 3 of the Town and Country Planning General Regulations 1992 subject to a unilateral undertaking to provide a contribution capped in the sum of £1,000,000 towards the provision of a new athletics track and allweather pitch at the Sports Hub to include:
  - a) the provision of a suitable temporary athletic facility on an area of land within The Newark Academy playing field boundaries;
  - b) the mechanism and timescale for the payment of the contribution towards the provision of a new athletics track and all-weather pitch at the Sports Hub; and
  - c) the provision of an all-weather pitch and athletics track on The Newark Academy Site, equivalent to existing facilities on The Newark Academy site, in the event that the provision of an allweather pitch and/or athletics track at the Sports Hub is not commenced within six years of the date of the deed.

and subject to the conditions set out in Appendix 3 attached to the report.

### DANESHILL LAKES LOCAL NATURE RESERVE DANESHILL ROAD NR LOUND RETFORD

Mr Smith introduced and took members through the report and gave a slide presentation. He informed members that there was an amendment to condition 4(c) as set out in the appendix attached to the report and it should read:-

"No more than two powered boats shall operate on the lake for the purpose of on water experience at any one time".

Mr Smith also clarified that, with reference to paragraph 38, the sailing club had confirmed that on-water experience trips for school children can take place whenever the club is operating but trips on days other than Wednesdays is rare. He also noted that the references to adult and junior members in paragraph 52 were in fact the total number of visits made to the lake for sailing last year whilst membership is generally between 60-80.

Following the opening remarks of Mr Smith, Mr Maurice Holmes, spoke in favour of the application on behalf of Daneshill Sailing Club highlighting the following :-

- Once it came to light that the club did not have the appropriate planning permission for this activity it was agreed with the County Council's Children Families and Cultural Services Department that this would be sought.
- There were no objections at the time of applying for the variation.
- The club does not want to change the nature of the site in anyway but do wish to continue giving on-water-experience.
- The club has no plans for expanding the size of the club or the number of boats involved in the trips.

Following Mr Holmes speech he responded to members questions as follows:-

- Anglers do use the lake whilst the boats are on the water and it is a bone of contention that they feel the club should not allow powered boats on the lakes.
- The sailing club operates under the Royal Yachting Associations strict guidelines on safety issues and therefore all passengers and sailors should wear a lifejacket at all times when on the water.

On a motion by the Chairman, seconded by the Vice Chairman it was:-

That planning permission be granted, subject to the conditions set out in Appendix 1 attached to the report with the amendment as set out above.
