## **A briefing for Overview and Scrutiny Committees – introducing the NICE field team**

The National Institute for Health and Clinical Excellence (NICE) is the independent organisation responsible for providing national guidance on the promotion of good health and the prevention and treatment of ill health.

Although much of our guidance refers to clinical practice in the NHS, in recent years our remit has broadened to include public health and so an increasing amount of NICE guidance also has direct relevance for local authorities, voluntary bodies, employers and the wider public. As our role has developed we have been keen to develop links with partners in local government.


Lucy Johns, Health Partnerships Officer with, Dorset County Council commented:
