REPORT OF THE SERVICE DIRECTOR, EDUCATION, LEARNING AND SKILLS

REVISED PROCEDURE FOR LOCAL AUTHORITY GOVERNOR NOMINATIONS AND RE-NOMINATIONS TO SCHOOL GOVERNING BODIES

Purpose of the Report

- The report seeks approval of a revised procedure for the nomination and re-nomination of Local Authority Governors to maintained school governing bodies and academy school local governing bodies. The revised procedure will allow the Service Director, Education, Learning & Skills, to approve school governor nominations for which the Council has responsibility and is required to report the decisions quarterly to the Children and Young People's Committee.
- 2. To update Committee on the appointment of Local Authority (LA) governors to school governing bodies for the period 1 January to 11 February 2019.

Information

- 3. The arrangements for the constitution of governing bodies of maintained schools are set out in the School Governance (Constitution) (England) Regulations 2012. In August 2017 the Department for Education issued statutory guidance for local authorities and governing bodies. It included guidance about the appointment of Local Authority governors.
- 4. The Regulations and Guidance state that governing bodies of maintained schools must include one Local Authority (LA) governor. Governing bodies may set eligibility criteria for the LA governor based on the skills gaps that the governing body has identified.
- 5. Under the 2012 Regulations, nominations are made by the County Council, in accordance with the eligibility criteria provided by the governing body, and are then considered for appointment by the governing body. When nominating new LA governors or re-nominating existing LA governors, the County Council must consider the skills and experience that the governing body has identified it is seeking in order to be effective. It should be noted that the Regulations allow a governing body to reject the prospective governor nominated by the LA if they feel that the person does not meet their eligibility criteria.
- 6. An individual eligible to be a staff governor at the school may not be nominated or renominated as a Local Authority governor.

- 7. The Corporate Director for Children and Families Services has delegated authority to approve school governor nominations for which the Council has responsibility and is required to report the decisions quarterly to the Children and Young People's Committee.
- 8. It is proposed to ask the Committee to delegate authority to the Service Director, Education, Learning & Skills, as well as to the Corporate Director for Children and Families Services, to minimise delays that might otherwise occur.
- 9. The process is that two reports are prepared containing information on both new and renominated LA governors and these are considered on a half termly basis. Before an existing LA governor is considered for re-nomination, the headteacher and chair of governors are asked if they have cause for concern about the individual serving another term of office (four years). Any stated concerns are considered before a decision to renominate is made. All decisions are recorded, with an explanation of how the decision was reached, to ensure transparency. Then it is for governing bodies to make the final decision on the appointment of the nominee.

Governing body appointments

10. Local Authority governors nominated by the County Council and appointed by school governing bodies during the period 1 January to 11 February 2019 are as follows:

Other Options Considered

11. There were no other options considered as the Corporate Director, Children and Families Services, and the Service Director, Education, Learning and Skills, sit at the appropriate level of operational independence and subject area knowledge.

Reason/s for Recommendation/s

12. The recommendation ensures the quality and suitability of the nominees, using the agreed eligibility criteria prior to approving their nomination or re-nomination. It will also support the speedy appointment of governors at a time of high vacancy levels.

13. This report has been compiled after consideration of implications in respect of crime and disorder, data protection and information governance, finance, human resources, human rights, the NHS Constitution (public health services), the public sector equality duty, safeguarding of children and adults at risk, service users, smarter working, sustainability and the environment and where such implications are material they are described below. Appropriate consultation has been undertaken and advice sought on these issues as required.

- 2) agrees to receive quarterly update reports in relation to the appointment of Local Authority governors to school governing bodies and that these be included in the work programme.
