REPORT OF THE DIRECTOR OF ENVIRONMENT

NATIONAL COMMUNITY FOREST CHAIRS' MEETING

Purpose of Report

To seek approval for attendance at the National Community Forest Chairs' Meeting and the associated travel and accommodation.

Information and Advice

- 2. Under the Travel and Accommodation Policy and other arrangements approved by the full Council on 7 October 2004, this Committee is the appropriate body for considering/approving attendance at a range of events and the travel and accommodation requirements arising therefrom.
- 3. This report describes a proposal which is within the Committee's decision-making powers and Members are asked to consider whether attendance at the event should be approved (including the number of representatives), together with any necessary travel, accommodation or other arrangements.
- 4. The information included within the following sections of the report should ensure compliance with normal decision-making rules. If attendance is approved, the details referred to below will be used to compile the public Register, which is available on the Council's web-site.

Reasons for attendance

5. The National Community Forest Chairs' Meeting takes place at the Blackwell Grange Hotel, Darlington on Tuesday 11 and Wednesday 12 October. 2005 The County Council is the lead body for the Greenwood Community Forest and provides the Chair for the Partnership Board. Approval is sought for Councillor Jim Napier as Chairman of the Greenwood Community Forest and Malcolm Hackett, Greenwood Project Manager, to attend. This conference is the annual meeting of the national 'family' of 12 Community Forests organised by the Department of Environment, Food and Rural Affairs. It provides a valuable opportunity for the exchange of ideas and intelligence and allows national issues

to be debated and fed back to Government. This year there will also be discussion on the new funding arrangements and on the important contribution community forests make to sustainable development.

Travel and Accommodation requirements

- 6. The County Council's representatives will require hotel accommodation at the conference venue at £75.00 per night each and travel and subsistence.
- 7. The costs associated with the event are as follows:-

8. The travelling expenses shown above are for 2nd class rail plus taxi travel. The County Council's representatives will be staying at the Conference Hotel so that they are closer to the business of the event.

The needs of individual travellers will have been considered when compiling the report and, where departures from the policy are recommended, Members should consider the reasons given.

10. That approval be granted for the attendance of Cllr. Jim Napier as Chairman of the Greenwood Community Forest and Malcolm Hackett, Greenwood Project Manager, at the National Community Forest Chairs' Meeting with travel and accommodation as necessary in connection with the event.
