# ANNUAL CONFERENCE OF THE TRADING STANDARDS INSTITUTE

# **Purpose of Report**

To outline the arrangements for this year's Annual Conference of the Trading Standards Institute and to consider representation at the Conference.

#### Information and Advice

- The Trading Standards Institute (TSI) represents the professional interests of the Service. Its Annual Conference, which is specifically designed to enable local authorities to have a full involvement with the issues of the day, will take place 24-26 June 2008 at the Bournemouth International Centre, Bournemouth.
- Each year the Conference attracts increasing numbers of delegates and the 2007 event was re-styled to appeal to the various stakeholders involved in the wider fields of consumer affairs. Hence the conference changed its title to 'Consumer Affairs and Trading Standards Conference and Exhibition'.
- The themes of the Conference also reflect the wider agenda and reflect the Trading Standards contributions to national and local priorities and how the service can help local authorities improve the social, economic and environmental wellbeing of its communities.
- 5 Key themes will include:
  - Who Rules Business or the Consumer
  - Regulators Who Needs Them?
  - Fair Trade in Local Global Markets
  - Protecting the Health and Welfare of Citizens
  - Mini Theatre Sessions
  - Consumer Challenge Quiz
  - Young Consumer of the Year Competition
- The Service Director Community Safety, Regeneration and Protection would recommend that the County Council is represented at this Conference as it is the only national Trading Standards event available that fully reflects all the interests of the local authorities. It is recommended that up to three County Councillors attend the Conference. Up to three Officers from the Trading Standards Service will be attending.
