REPORT OF THE DIRECTOR OF RESOURCES

LGC PUBLIC SECTOR PENSION FUND INVESTMENT SEMINAR

- 1. <u>Purpose of the Report</u>
- 1.1 To seek approval for three Members and one Officer to attend this seminar which is being held at Southampton on 8 and 9 September 2005 and for the associated travel and accommodation costs.
- 2. Information and Advice
- 2.1 Approval is sought within the terms of the Council's Conference and Travel Policy for attendance at this seminar. It is regarded as the prime event in the year for Local Authority Pension Funds, and has been attended by Members of the Pensions Committee for the last 15 years. At a recent meeting of the Pensions Investment Sub Committee, attendance at this conference was recommended for 2005/6, because it brings together all topical matters for Local Authority Pension Funds, and provides the element of training which is essential for Members of the Pensions Committee and its Sub Committees to have in order to carry out their responsibilities.
- 2.2 The registration fee for the seminar is £726 per delegate, provided booking is done by 30 April 2005. This includes accommodation for 8 September, and it has been customary to stay for the night preceding the seminar at a cost of £130 per delegate.
- 2.3 The summary of costs involved with this event are:-
