<u>BETTER BROADBAND FOR NOTTINGHAMSHIRE – ADDITIONAL BROADBAND DEPLOYMENT</u>

Phil Berrill, Broadband Programme Officer, made a short presentation to Members on further superfast coverage. The proposal will take Superfast Fibre Broadband coverage for Nottinghamshire to around 98.2%. An additional 153 structures will enable 3037 premises have access to Fibre Broadband, of which 2610 are estimated to receive superfast speeds. Rural areas are now being reached, and further detailed mapping will take place to ensure that figures are robust. As with Contract 1, the solutions deployed will be a combination of: Fibre to the Cabinet, Exchange Only Cabinets, Fibre to the Premises. Mr Berrill explained that some broadband issues are customer service related, whereas other problems relate to superfast broadband dropping out at particular locations.

HIGH SPEED TWO (HS2) - THE EAST MIDLANDS GROWTH STRATEGY

Purpose of the Report

 To offer the Committee an overview of the economic development aspects of the proposed HS2 developments as they impact upon Nottinghamshire and the wider region, facilitated via a presentation by Andrew Pritchard, Director of Policy and Infrastructure at East Midlands Councils and member of the East Midlands HS2 Executive Team.

Background

- 2. This report and presentation is offered as an introduction to the HS2 as it impacts upon Nottinghamshire and the wider East Midlands area and specifically, focuses upon the economic development and growth aspects of the development of the HS2 line, the East Midlands Hub station and related aspects.
- 3. The East Midlands HS2 Strategic Board is developing a comprehensive HS2 Growth Strategy to be submitted to Government by July 2017 with the Council's Policy Committee endorsing the then "Emerging HS2 East Midlands Growth Strategy" at its meeting on the 21st September 2016. The presentation will major on the economic opportunities afforded as a consequence of HS2, will review the Emerging Strategy as well as reflecting on the work that is progressing since then, and what progress is being made towards the final submission in July.
- 4. Members will be aware that reports on HS2 are generally considered by the Transport & Highways Committee, covering the preferred route, any proposed refinements and (road and rail) connectivity to the proposed East Midlands Hub Station with Policy Committee considering matters of policy such as referenced above. The Economic Development Committee has yet to receive a report on HS2 and while majoring on the Growth Strategy's progress, the presentation will offer some broader context and offer insight into the governance and management arrangements for HS2 and the Growth Strategy.

INTRODUCTION TO THE NEWLY APPOINTED CHIEF EXECUTIVE OF MARKETING NOTTINGHAM AND NOTTINGHAMSHIRE

Purpose of the Report

- 1. Committee will receive an introductory presentation from the newly appointed Chief Executive for the organisation charged with promoting Nottingham and Nottinghamshire as a destination for inward investment, tourism and talent.
- 2. A formal performance report on Marketing Nottingham and Nottinghamshire is proposed for Autumn 2017.

Information and advice

- Nottinghamshire County Council has maintained a consistent and active role in both inward investment and tourism marketing activity for many years. Committee first received reports on proposals to establish a Place Marketing Organisation (PMO) for Nottingham and Nottinghamshire in April 2014.
- 4. In advance of the *Invest in Nottingham* service becoming part of this new PMO Marketing Nottingham and Nottinghamshire (MN&N), in February 2016 Committee received a report on the operational activity of the inward investment service (covering 2015/16 financial year).
- 5. Formed out of the previous tourism marketing company, Experience Nottinghamshire, by April 2016 the formal transfer of staff and resources from Invest in Nottingham and Nottingham Means Business to MN&N had been implemented. An acting Chief Executive was appointed pending recruitment of a permanent post holder.
- 6. Today MN&N is primarily funded by the City and County Councils, with additional support from other public and private sector organisations. This Committee committed funding from 1st October 2015 to 30th September 2018 at a level of £200,000 per annum. A full-time Band C Economic Development Officer is based with the MN&N team to undertake inward investment activities. Several of the District/Borough Councils fund and deliver tourism and inward investment marketing activities in their areas.

7. Plans for the County Council to undertake a half-yearly performance review with MN&N in October 2016, along with a formal annual performance report scheduled for May 2017, were referenced in a report to this Committee in July. As the first permanent Chief Executive for MN&N was not in post until late September, the half-yearly performance review did not happen. Committee will instead receive a presentation from Brendan Moffett on his plans for the organisation, with a view to an annual performance report being presented in the autumn of 2017.

MN&N achievements

8. As highlighted in 2016-17 Delivery Plan Review Report (introduced at 6th December 2016 meeting), the following headline figures were stated:

Inward Investment:

- For the period April to August 2016, 10 projects converted to successes, yielding a total of 542 jobs.
 - The pipeline of 'Live' enquiries stood at 62 projects a potential yield of >2,600 jobs

Tourism in Nottinghamshire:

- Figures revealed in the STEAM¹ 2015 report showed "...there was a significant boost to Nottinghamshire's visitor economy":
 - Value of tourism in Nottinghamshire (excluding city) (£m) £1.051bn
 - Volume of tourism in Nottinghamshire (excluding city) (m) 22.21m
 - Full Time Equivalent (FTE) jobs supported by tourism 14,218
 - Average spend per trip £47.32

Volume (m)	20.09m	2.115m
Value (£m)	£698m	£353m
Average spend per visitor	£34.74	£166.90

DERBY-NOTTINGHAM METROPOLITAN STRATEGY CONSULTATION – COPY OF RESPONSE FROM NOTTINGHAM CITY COUNCIL

Purpose of the Report

1. To provide Committee with a copy of Nottingham City Council's response to Nottinghamshire County Council in relation to the Derby-Nottingham Metropolitan Strategy Consultation.

Information and advice

- 2. Having considered the draft Derby-Nottingham Metropolitan Strategy 2030 (Metro Strategy) on 6th September, Nottinghamshire County Council submitted a formal response to the Consultation on 14th September 2016 to both Derby and Nottingham City Council Leaders.
- 3. In its role as secretariat for the Economic Prosperity Committee (EPC), Nottinghamshire County Council was approached (9th December) by Nottingham City Council to include the Metro Strategy as an agenda item for 6th January meeting. This gave rise to County Council Officers chasing the City Council for a reply to the formal response to the Consultation.
- 4. On 30th December, the City Council confirmed that they had not received the letter (until a copy of the letter had been resent) and promised a response ahead of the EPC. *Appendix A* contains the response received from Nottingham City Council (via email) on 5th January 2017.
- 5. Two decisions were made at 6th January EPC on the Metro Strategy agenda item and were recorded as follows:
 - That the development of the Derby-Nottingham Metro Strategy and the intention of Nottingham and Derby City Councils to engage further with neighbouring authorities be supported in principle.
 - That the work on the Town Centre Strategy and Rural Strategy be noted and updates be brought to a future meeting.

Reasons for recommendation(s)

6. The Economic Development Committee requested to receive a copy of the reply to Nottinghamshire County Council's formal response to the Derby-Nottingham Metropolitan Strategy Consultation.

Re: Derby-Nottingham Metro Strategy Consultation

Thank you for sending me the County Council's response to the Metro Strategy consultation, and apologies for the delay in my response, but your letter only arrived in my office on 21st December.

I am pleased that the County Council wishes to engage and contribute to the Metro Strategy, as there are clear areas of mutual interest and benefits to be gained through collaboration. I recognise the concerns that you raise and have sought to address some of the concerns in our response to the consultation.

In its early stages, many of the Metro Strategy actions are concerned with joint working between the two City Councils on issues specific to the cities. Nevertheless, we recognise the statutory responsibilities and strategic interests of our neighbouring authorities – Counties and Districts – on the range of issues that cover the wider Metro area, and the revised action plan reflects our commitment to continued engagement and collaboration with County and District Councils.

A Metro Strategy Delivery Board (chaired by myself and Ranjit) held its first meeting just before Christmas to consider the Strategy and Action Plan as it emerged from the consultation (summary versions are attached). The Board wholeheartedly agreed the need for further engagement, which could include working in partnership on specific initiatives, regular meetings at senior officer and political level, and representation on the Strategic Advisory Group that is being established.



Chris Henning (my Strategic Director, Economy) is presenting an overview of the Metro Strategy at the forthcoming N2 Economic Prosperity Committee meeting on 6th January. I have asked Chris to arrange to meet Adrian Smith and Senior District Officers for a more detailed discussion about our engagement as soon as possible after the EPC meeting.
