# LOCAL GOVERNMENT ASSOCIATION ANNUAL CONFERENCE AND EXHIBITION BOURNEMOUTH INTERNATIONAL CENTRE $4^{\text{TH}} - 7^{\text{TH}}$ JULY 2006

### **Purpose of Report**

 To seek approval for attendance at the Local Government Association's Annual Conference and Exhibition 4 – 7 July 2006 in Bournemouth.

#### Information and Advice

2. The County Council is a member of the LGA, which aims at improving life in local communities. Each year, the LGA holds a number of conferences on a range of issues of interest to local authorities. The annual conference, which is the main conference event in the business year, is open to representatives of all member authorities. It aims to provide the opportunity to hear from local and central government figures on issues which affect the whole community. It also enables information sharing, promotion of local and national initiatives, learning opportunities for those who attend, through conference sessions and the ability to network effectively with representatives across the whole spectrum of local authority public service.

#### Reasons for Attendance

- 2.2 Next year the conference will focus on:
  - local leadership
  - local devolution
  - local improvement

- 2.3 Local government is committed to local leadership, to building on the track record to deliver further improvements in services and the LGA is committed to devolution beyond the town hall, to neighbourhoods and communities.
- 2.4 With the right tools, councils can deliver cleaner and greener neighbourhoods, cut crime and improve the health of local communities.
- 2.5 It has been the Council's practise to permit attendance at this important conference by its representatives on the LGA; the Leader of the main minority group and the Chief Executive.

#### **Travel and Accommodation Requirements**

- 3. The County Council's representatives will require hotel accommodation, rail fare etc.
- 3.1 The costs associated with the event are as follows:-

- 3.2 The travelling expenses shown are for standard class rail.
- 3.3 The figures shown for accommodation are in respect of rooms at a hotel located within a reasonable distance from the event.

#### **Statutory and Policy Implications**

4. This report is necessary to ensure compliance with the Council's Travel and Accommodation Policy and current arrangements for approving attendance at conferences, seminars and Member Training events. The needs of individual travellers will have been considered when compiling the report and, where departures from the policy are recommended, Members should consider the reason given.

5. That approval be given for the attendance of five Councillors plus one Officer at the LGA Annual Conference and Exhibition to be held in Bournemouth 4 – 7 July 2006.
