REPORT OF THE SERVICE DIRECTOR TRANSPORT, PROPERTY AND ENVIRONMENT

CHANGES TO THE TRENTBARTON COMMERCIAL BUS SERVICE 27

Purpose of the Report

1. To inform Committee of changes to Trentbarton commercial service 27 from 1 December and to seek approval for the revision of supported services 531, 532 and 402.

Information and Advice

- 2. Trentbarton have announced changes to commercial service 27 operating from Ilkeston Awsworth Kimberley which will leave the Kimberley Maws Lane and Hardy Street areas with no bus service.
- 3. The above area has a high number of elderly residents who rely on public transport to access key amenities in Kimberley and Eastwood. In order to ensure that these areas have a bus service it is proposed to revise the County Council's 531, 532 and 402 services which were introduced in August 2014 to include an off-peak service to Maws Lane and Hardy Street.
- 4. In addition the revised services will also improve and provide:
 - An off peak service from Selston via Underwood Moor Green and Watnall to Phoenix Park
 - A divert bus service from Moor Green to Eastwood
 - A link between Selston Underwood
- 5. For reference a bus route map (Appendix 1) and timetable (Appendix 2) are attached.
- 6. It should be noted that the revised 531, 532 and 533 (previously 402) will be operated by County Council fleet vehicles which also operate journeys to and from Day Centres.

Reasons for Recommendations

7. The recommendation and continued financial support meet the objectives of promoting public transport, reducing congestion, promoting economic recovery and offering travel choices.

Statutory and Policy Implications

8. This report has been compiled after consideration of implications in respect of crime and disorder, finance, human resources, human rights, the NHS Constitution (Public Health only), the public sector equality duty, safeguarding of children and vulnerable adults, service users, sustainability and the environment and ways of working and where such implications are material they are described below. Appropriate consultation has been undertaken and advice sought on these issues as required.

Implications for Service Users

9. The provision of the revised local bus service enables users to access key services, jobs, health and leisure.

Financial Implications

10. Initially the additional costs relating to the provision of the supported bus services are expected to be £38,000 per year which will be funded from the surplus Bus Lane Priority Enforcement revenue. The Committee should note that the use of one Day Centre vehicle to operate local bus services has also reduced the cost of social care transport by £20,000 as a consequence of higher utilisation.

RECOMMENDATIONS

It is recommended that Committee:

- 1) Note the changes to the Trentbarton service 27
- 2) Approve the changes to the timetables for local bus services 531, 532 and 402
- 3) Approve funding the additional costs arising as set out in paragraph 10 of the report



THE NOTTINGHAMSHIRE COUNTY COUNCIL (VARIOUS ROADS IN ATTENBOROUGH) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2014 (5152)

CONSIDERATION OF OBJECTIONS

Purpose of the Report

1. To consider the objections received in respect of the proposed Traffic Regulation Order for the Attenborough Area.

Information and Advice

- 2. Attenborough is a small village situated in a conservation area between Beeston and Long Eaton to the south-west of Nottingham. The village is mainly residential but it hosts a train station together with a number of small shops and businesses. There is a cement works at the north-east end of the village which generates a number of Heavy Good Vehicles (HGVs) travelling through the area. Attenborough Nature Reserve at the south-east end of the village which attracts many visitors and although vehicular access is via Barton Lane there is also pedestrian access via Attenborough Lane.
- 3. Parking in the area has become an increasing issue with rail commuters travelling to Beeston and Nottingham leaving their vehicles all day on local streets. Parking restrictions were implemented in March 2013 to address some of the issues (TRO 5130) but problems are still occurring on the approaches to the level crossing in the village. This is causing an ongoing safety concern.
- 4. Additional restrictions were consulted on between 28th April and 28th May 2014 and then publicly advertised between 24th July and 22nd August 2014. The extent of the scheme proposals are shown on the attached drawing H/04078/1982.

Objections received

5. During the consultation and public advertisement of the proposals 15 responses were received, with 12 considered as outstanding objections from households, individuals or organisations which are summarised below:

6. <u>Objections – Four Attenborough Residents and Attenborough Community Action Team</u> Four local residents are objecting on the basis that the proposals will not alleviate the current parking problems and just further displace parking further down Barratt Lane, Long Lane and Attenborough Lane. A number of pinch points on the road network further away from the level crossing have also been identified by objectors with double parking restricting traffic to a single lane in places with limited passing places. Objectors suggest that parking close to vehicular crossings is creating difficulty with visibility when exiting driveways.

An objector suggests the problems are caused by charges at Beeston and Long Eaton train stations resulting in commuters choosing to catch trains at Attenborough to park on street and avoid charges.

An objection has been received via Borough Councillor Eric Kerry following meetings of the Attenborough Community Action Team (CAT). Similar issues have been raised by local residents regarding parking being displaced to other areas. In addition concerns have been raised regarding double parking on both sides of Elm Avenue, Ireton Grove, Barratt Close and sections of Barratt Lane particularly close to the Barratt Close junction. It has been suggested that the proposals is just another incremental step and not a holistic scheme that is required to protect the amenity of residents and ensure that passenger numbers at the station remain sustainable.

Alternative suggestions include parking limited to two hours to allow visitors and tradesmen to visit or a one hour restriction (10 - 11am, Monday to Friday) and the edition of H-bars to discourage parking too close to driveways.

A long term solution suggested would be to build a car park on the north side of the railway line on a site adjacent to the gravel works on Long Lane with a new footpath to the station adjacent to the railway line.

In general some of the objectors agree that double yellow lines on both sides of Attenborough Lane will be safer.

7. <u>Response – Four Attenborough Residents and Attenborough Community Action Team</u> The additional proposals follow the implementation of 'No Waiting At Any Time' restrictions in March 2013 and are as a result of ongoing concerns raised by the local County Councillor, local residents and Network Rail that obstructive parking on the approach to the level crossing is causing a safety issue.

Wider issues and concerns are acknowledged by the County Council and other stakeholder. As a result, on 30th May 2014 a meeting was held with representatives of East Midlands Trains, Network Rail, Cemex, Anna Soubry MP, County Councillor Steve Calvert and Borough Councillor Eric Kerry. This meeting discussed parking problems in Attenborough and agreed a number of actions including:

• A survey of passengers using Attenborough Station (to understand where people have travelled from, their destination and why they have chosen Attenborough); A recent survey carried out by East Midlands Trains indicates that at present 80% of customers at Attenborough Station actually arrive from postcodes that may be expected to use Beeston or Long Eaton Stations.

- The introduction of parking restrictions to help alleviate incidents of dangerous parking close to the railway level crossing;
- A wider review of parking in the village;

The investigations highlighted above are ongoing and the proposed restrictions included in this consultation are aimed to alleviate the safety concerns around the level crossing. They are not intended to be an area-wide solution; this is considered outside the scope of this consultation. Any wider holistic approach such as limited waiting parking bays or single yellow lines need to balance the needs of residents, visitors, local businesses, commuters and any other road users. Discussions around the availability of land and options for a railway car park should be concluded prior to any further restrictions being proposed as this would influence the type and extent of the additional restrictions.

Since the decriminalisation of parking offences the police no longer have the power to enforce parking / waiting restrictions. These are the responsibility of the Highway Authorities Civil Enforcement Officers (CEO's). The additional proposed parking restrictions will enable enforcement action to be taken against drivers contravening these restrictions. The local police are still responsible for dealing with issues of obstruction and dangerous parking.

An appropriate measure to help alleviate difficulties with vehicle access / egress to properties is the provision of advisory 'H bar markings' and these can be provided in line with the County Council's charging policy (£175) on request from local residents.

8. <u>Objection – Attenborough Lane resident close to level crossing</u>

A local resident close to the train station is objecting due to problems they would personally encounter due to limited off-road parking and a multiple car household along with issues with visitor parking. Problems suggested are two-fold, the first being all day commuter parking and secondly increased traffic around peak times due to commuters being dropped off close to the station. It has been suggested that single yellow line parking would suffice or residents parking.

9. <u>Response – Attenborough Lane resident close to level crossing</u>

The 'No Waiting At Any Time' restrictions (double yellow lines) on approaches to the level crossing are proposed to keep traffic lanes clear of parked vehicles at all times in advance of the double white lines system used around level crossings. Whilst a less restrictive option could be used as an alternative it is considered appropriate for these to be 24 hours a day to reduce the risk to road users around the level crossing. Properties around the level crossing have off-road parking provision and further unrestricted parking is available on-street in the wider area.

10. Objections – Allendale Avenue

Two local residents of Allendale Avenue are objecting to the proposed restrictions around the Allendale Avenue / Attenborough Lane junction. This is due to concern about residential parking for visitors plus provision for any local trade persons carrying out works, parking being further displaced along the road and access off driveways being difficult due to parking opposite and close-by. The objector has also raised an issue about vehicles waiting short times to pick up people arriving by train. One resident suggests extending restrictions further along Allendale Avenue to prevent parking opposite residents driveways, widening the road or the introduction of residents only parking.

11. <u>Response – Allendale Avenue</u>

The restrictions around Allendale Avenue consist of the minimum amount of junction protection into the side road (Allendale Avenue) and additional double yellow lines on approaches to the level crossing on Attenborough Lane. These are considered the minimum required on safety grounds. Both objections demonstrate differing views of residents on the same street and it is considered overly restrictive at this stage to extend further into Allendale Avenue and anything else would need to be part of a wider holistic solution. As stated advisory 'H bar markings' are available on request and payable by the local resident.

Proposed restrictions on Long Lane at the side of 205 Attenborough Lane have been reduced from 24-hour double yellow lines to single yellow lines (Monday to Saturday 8am – 6pm) as a result of feedback from the initial consultation. The restrictions are still considered necessary to keep the wider junction areas clear during the working day, particularly due to the proximity of the bus stop but the reduced time restrictions will provide further unrestricted parking after 6pm / before 8am and on Sundays.

12. Objections – Commuters

Three commuters are objecting to the proposals, a number of issues have been raised and these include suggestions double yellow lines are not required providing driveways are not blocked, questioning why restrictions extend down streets that are not near to the level crossing and that provision should be made of short-term limited waiting to enable an area where people can wait close to the station (suggesting 30 minutes) to allow people to be collected from the train. All these objectors have concern about removing parking provision without providing an alternative solution and are asking how the council is proposing to support commuters and residents who wish to use Attenborough railway station.

Some of the commuters have also experienced aggressive behaviour when parking in unrestricted areas on the road due to no official parking facilities for the train station.

13. <u>Response – Commuters</u>

The proposed restrictions are primarily located on approaches to the level crossings, they are extended into streets not on direct approach to the level crossing to help keep these areas clear and allow for unobstructed exiting of these junction areas with increased visibility.

As previously stated work is ongoing into options around off-street car parking for the railway station and wider parking restrictions. The consultation has demonstrated opposing views from local residents and commuters around these issues.

Areas of public highway that have no parking restrictions are available for use by any road user to park, but this needs to be done in both an unobstructed and considerate manner.

14. Objection – Ireton Grove

A household on Ireton Grove is objecting as proposals for restrictions on Long Lane are likely to further displace parking onto Ireton Grove. The residents suggest that the street already has parking problems due to properties having no off-road parking as a result of large extensions and that access to their driveway is sometimes blocked or difficult due to parked vehicles. Concern has also been expressed about speeding vehicles along Long Lane.

15. <u>Response – Ireton Grove</u>

No further parking restrictions are currently in progress in the wider area of Attenborough for reasons discussed elsewhere in the report. As stated residents can request and pay for advisory 'H bar markings' across driveways to help keep these clear. The issue of speeding is outside the scope of this report, but will be logged with the relevant highways officer.

Other Options Considered

16. Other options considered relate to the types of restrictions and this was reflected in the change of restriction on Long Lane following the initial consultation (as detailed in paragraph 11).

Reasons for Recommendations

17. The proposed restrictions are being introduced to improve safety on the approaches to the level crossing and to provide junction protection.

Statutory and Policy Implications

18. This report has been compiled after consideration of implications in respect of crime and disorder, finance, human resources, human rights, the NHS Constitution (Public Health only), the public sector equality duty, safeguarding of children and vulnerable adults, service users, sustainability and the environment and ways of working and where such implications are material they are described below. Appropriate consultation has been undertaken and advice sought on these issues as required.

Financial Implications

19. The scheme is being funded through the 2014/15 Traffic Management revenue budget – Broxtowe at a cost in the region of £1,500.

OBJECTIONS TO PERMANENT TRAFFIC REGULATION ORDERS – UPDATE ON SERVICE DIRECTOR APPROVALS

Purpose of the Report

1. To provide Transport and Highways Committee with an update on operational decisions made when considering objections received through the consultation and advertisement of Permanent Traffic Regulation Orders.

Information and Advice

- 2. A Traffic Regulation Order (TRO) is a legal order, which allows the County Council to regulate the speed, movement and parking of vehicles. Nottinghamshire County Council as Local Highway Authority has a responsibility to consider all objections received before making a TRO permanent.
- 3. To avoid undue delays and for the efficiency of Committee on 12th July 2012, Transport and Highways Committee approved an approach that permitted officers to determine, as operational matters, TROs with three objections or fewer with the following exception that are referred to the Committee for consideration, these include:
 - those which have received significant objections from consultees more than three objections from separate properties that cannot be resolved by amendments to the scheme;
 - those which have received objections from the local County Councillor/s, formal decisions of District or Parish Council/s or another local authority;
 - those which have received objections from Public Transport Operators or Associations, Road Haulage Association, Freight Transport Association, Highways Agency, Traffic Commissioner or emergency service;
 - those which have received objections by petition;
 - those which have been the subject of a public inquiry
- 4. The current process for considering objections by officers is a report from Team Manager, Major Projects and Improvements to the Service Director for Highways. These are presented in a similar format to committee reports.

RESPONSE TO PETITIONS PRESENTED TO THE CHAIRMAN OF THE COUNTY COUNCIL ON 18TH SEPTEMBER 2014.

Purpose of the Report

1. The purpose of this report is to recommend to Committee the responses to the issues raised in petitions presented to the County Council on 18th September 2014.

Petition Regarding Service 22 Nottingham – Cotgrave – Cropwell Bishop (Ref 2014/080)

- 2. A 212 signature petition was presented to the 18th September meeting of the County Council requesting that Service 22 be restored.
- 3. Until August this year Service 22 provided an all-day service between Nottingham Cotgrave Cropwells and villages in the Vale of Belvoir.
- 4. From August, Service 22 was integrated into Trentbarton's new commercial Rushcliffe Green network which services Radcliffe-on-Trent – Bingham – East Bridgford and villages in the Vale of Belvoir. This new service provides a 30 minute frequency from all destinations throughout the day. In addition Service 22 provides two morning and one afternoon peak service to and from Cropwell Bishop. The new services also provide better bus services to other villages in the area.
- 5. It should be noted changes to the bus services as outlined above were made as part of a competitive tendering process and achieved savings of approximately £300k a year.

- 6. Monitoring of the new service is taking place and all the services will be reviewed in liaison with the operator to see if any future changes are necessary to improve the service. Any changes will need to be considered in the context of wider review of the entire network and future funding decisions by the County Council. Accordingly, there are no immediate plans to restore the rest of Service 22.
- 7. It is recommended that the lead petitioner be informed.

Petition Requesting A Speed Restriction And Enforcement On Oxton Road, Calverton (Ref: 2014/078)

- 8. A petition was presented to County Council on 18 September 2014 by Councillor Boyd Elliot on behalf of 28 residents of the B6386 Oxton Road, Calverton. The petition requested a reduction in the speed limit from de-restricted to 40mph along with the introduction of speed cameras to improve road safety.
- 9. Initial investigations have been carried out into the reported injury accidents that have occurred along this road. However, further detailed surveys will need to be undertaken to determine whether a reduction in the speed limit would be effective. Officers have also arranged a meeting with Councillor Elliot and community representatives to discuss their concerns and potential solutions.
- 10. Any proposed scheme would be subject to the necessary consultation, statutory undertakings and other issues arising from feasibility studies, detailed scheme investigation and design, as well as value for money assessments.
- 11. It is recommended that the lead petitioner be informed.

Petition Requesting Road Safety Improvements On Wood Lane/Carr Road, Gringley On The Hill (Ref: 2014/081)

- 12. A petition was presented to County Council on 18 September 2014 by Councillor Liz Yates.
- 13. To maximise accident savings the County Council's investment in road safety measures is prioritised at sites with a record of injury accidents. Between 1 January 2011 and 31 May 2014 there has been only one reported slight injury accident on Wood Lane/Carr Road, at the Wood Lane/West Wells Lane junction. The accident involved a pedal cyclist entering the carriageway from the footpath and there is no indication that speed was a contributory factor to the accident. Given the low number of road traffic casualties on Wood Lane/Carr Road it is not recommended that engineering measures to address accidents is promoted at this time. Reported casualties will, however, continue to be monitored.
- 14. In July 2014, following community concerns, a speed survey was undertaken on Wood Lane near its junction with West Wells Lane. The survey recorded 85th percentile speeds of 29.5mph and therefore neither the traffic speeds nor the level of accidents meet the criteria to enable us to undertake mobile speed enforcement in the area.
- 15. Officers have, however, recently met with Councillor Yates, the parish council and local employers who use Wood Lane/Carr Road. The meeting included discussions about the perceptions that both Wood Lane and Carr Road are narrow and vehicles are travelling too fast, as well as HGVs use of the road.Page &bontsecouncil is also planning to install

additional HGV direction signing during the current financial year.

16. It is recommended that the lead petitioner be informed.

Petition Concerning Road Traffic Issues On A60 Loughborough Road, Ruddington (Ref: 2014/083)

- 17. On 18th September 2014 a petition from 55 Ruddington residents was presented to the County Council by Councillor Reg Adair. The petition concerned the increase in lorry traffic noise, the speed of vehicles and the poor condition of the road in places on the A60 Loughborough Road, Ruddington.
- 18. The A60 Loughborough Road, between Easthorpe Street and Ashworth Avenue has been identified as requiring inlay surfacing and therefore is included in the provisional 2015/16 capital maintenance programme which was approved at Transport & Highways Committee on 9 October, 2014. Speed surveys undertaken on A60 near Ashworth Avenue recorded the 24 hour 85th percentile speed as 43.5mph, within the ACPO guidelines for tolerance (46mph in a 40mph speed limit). The proposed resurfacing scheme will improve the condition of the road surface and therefore should reduce the level of noise being generated by the traffic at all times of the day.
- 19. It is recommended that the lead petitioner be informed.

Petition Requesting The Extension Of On-Street Waiting Times In Eastwood (Ref: 2014/087)

- 20. A 368 signature petition was presented to County Council on 18 September 2014 by Councillor Keith Longdon. The petition requests the extension of 30 minute short-stay waiting times to 1 hour in Eastwood.
- 21. The County Council reviewed the current short-stay parking arrangements in the whole of Eastwood during 2013 and the review included the consideration of extending existing 30 minute on-street waiting time to 1 hour. Currently there are 30 minute waiting restrictions in force close to Mansfield Road and Nottingham Road in Eastwood town centre and on Nottingham Road, Hilltop.
- 22. At both the Mansfield Road and Nottingham Road locations there is a demand for very short-stay spaces (30 minutes) as there is plenty of longer-stay nearby off Nottingham Road (both off-street parking and 1 hour on-street parking). The current mix of very short-stay parking of 30 minutes in areas of peak demand where the nearby shops benefit from a quick turnover of vehicles parking supplemented by longer-stay parking nearby provides the best balance between demand and supply and makes the most effective use of available highway parking in the town centre.
- 23. The Eastwood parking review did, however, highlight that, given the types of shops on Nottingham Road, Hilltop, there may be benefits from extending the existing on-street shortstay parking at this location from 30 minutes to 1 hour. A scheme to extend the on-street waiting restrictions on Nottingham Road, geithtop the ing the current financial year was

approved at the 13 February 2014 Transport & Highways Committee and is currently due to be implemented by 31 December 2014.

24. It is recommended that the lead petitioner be informed.

Petition Concerning Road Condition Of The A6005 Queens Road, Beeston (Ref: 2014/084)

- 25. On 18th September 2014 a petition of 263 names was presented to Full Council by Councillor Kate Foale concerning the number of potholes, the general state of the road and the volume of traffic on the A6005 Queens Road, Beeston.
- 26. The A6005 Queens Road, between Station Road and Meadow Road has been identified as requiring resurfacing and features in the Provisional Integrated Transport & Highway Maintenance Capital Programme 2015/16 which was approved at Transport & Highways Committee on 9th October, 2014. This scheme will improve the road surface. Part of the increased volume of traffic is associated with road works around Beeston connected with Phase 2 of the Tram Network expansion and are expected to reduce when the works are complete.
- 27. It is recommended that the lead petitioner be informed.

Petition Requesting Pavement Reinstatement On Lower And Fletcher Roads, Beeston (Ref: 2014/086)

- 28. It is the responsibility of the principal contractor to reinstate the footways along the route and it will do so as previously agreed. The decision to use tarmac to finish the footways is in keeping with previously made commitments in respect of the whole route and as included in material supporting the public inquiry.
- 29. This position has the support of both local highway authorities and is in keeping with each of their respective current practices to relay tarmac on footways. The use of tarmac is more cost effective in terms of ongoing maintenance.
- 30. As recognition of the difficult circumstances which the residents of Lower Road and Fletcher Road have faced for several months the County Council has some funds available through the Local Transport Plan to carry out environmental improvement in the area. These funds were allocated as part of the 2014/15 budget setting process and residents have been asked to consider what improvements it would like to see take place. Suggestions include such as information boards detailing local history or possibly a gateway feature.
- 31. Officers will continue to work with the local County Councillor and residents over winter with a view to installing improvements in spring 2015.
- 32. It is recommended that the lead petitioner be informed. Page 36 of 48

Petition Regarding Car Parking In Beeston (Ref: 2014/085)

- 33. A petition signed by 35 Beeston residents was presented to County Council on 18 September 2014 by Councillor Kate Foale. The petition raises concerns about volume, frequency, and nature of cars parking in the Dovecote Lane area; the speed and volume of traffic using Dovecote Lane; the potential impact of tram and train customers parking in the area; and the lack of reasonably priced car parking in the area.
- 34. An area wide parking study was undertaken in 2012 from which a number of local restrictions were introduced ahead of any more strategic measures arising from major developments. Those Traffic Regulation Orders resulted only in waiting restrictions to address parking on particularly narrow stretches of road or those with poor visibility etc. As part of the consultation process a resident requested a residents' parking scheme on Dovecote Lane. The County Council has therefore recently carried out a parking survey on Dovecote Lane north of Queens Road to determine the current levels of commuter/non-commuter parking. The County Council has also commissioned a survey to determine traffic speeds and volumes on Dovecote Lane. Once all the surveys have been undertaken and their results analysed, the County Council will be able to determine what scheme (if any) would best address the issues raised, and any proposals will be discussed with the local residents. Any proposals would be subject to achieving the required levels of public support and the availability of funding.
- 35. Parking restrictions in and around Beeston and Chilwell are currently under review by the County Council, particularly relating to potential impacts of NET Phase 2. To that end before the tram works started surveys were undertaken to establish the current levels of parking so that we can determine changes in parking patterns once NET Phase 2 becomes operational.
- 36. The experience of NET line 1 has shown that parking at local tram stops is not a major issue as access to the intermediate stops is not as attractive as the free park and ride car parks where there is better security. Having said this it may be that parking patterns are different on NET Phase 2 and therefore the County Council has in addition undertaken pre tramworks parking surveys near all of the proposed NET stops, including Dovecote Lane. The County Council also intend to undertake post tram-opening surveys on which to base any assessment of the level of parking potentially caused by tram users or other road users and should the need arise the 2015/16 funding allocated for parking improvements will be prioritised to address parking issues arising from NET Phase 2.
- 37. Broxtowe Borough Council is responsible for off-street car parks in Beeston, including the level of parking charges. A copy of the submitted petition has therefore been passed to Broxtowe Borough Council so that they can consider the comments made about parking charges in Beeston and the County Council will discuss the overall parking provision in the area with them.
- 38. It is recommended that the lead petitioner be informed.

Petition Requesting Measures To Improve Parking Conditions On Peveril Road, Beeston (Ref: 2014/077)

- 39. A petition was presented to County Council on 18 September 2014 by Councillor Steve Carr on behalf of residents of Peveril Road and Kenilworth Street, Beeston. The petition states that the introduction of parking charges in Beeston and the workplace parking levy has significantly worsened parking conditions on Peveril Road.
- 40. As in many locations, the County Council has an on-going programme of review and proposed changes to on-street parking restrictions in Beeston and Chilwell. This has resulted in several schemes being introduced to address existing parking issues such as new residents' parking schemes on Endsleigh and Muriel Gardens and Glebe Street, as well as junction improvements to Coventry Rd/Humber Rd junction in Beeston and parking restrictions near Attenborough train station.
- 41. We are also currently monitoring several sites following requests for parking schemes due to current levels of parking (e.g. Coventry Road, Dallas York Street, and Grove Street/Barton Street). A number of streets close to NET stops (including Peveril Road) are also being monitored in case there are parking impacts when NET Phase 2 becomes operational.
- 42. As it can be seen the Council is already responding to the many parking issues across Beeston and Chilwell. Peveril Road and Kenilworth Street will, however, be monitored and if necessary considered for an appropriate parking scheme in a future years' integrated transport programme. It should be noted that if the need arises the 2015/16 funding allocated for parking improvements will be used to address parking issues arising from NET Phase 2 and therefore a scheme may be considered on these roads should they be affected by NET related parking.
- 43. It is recommended that the lead petitioner be informed.

Petition Requesting A Residents Parking Scheme On Cator Lane North, Chilwell (Ref: 2014/079)

- 44. A petition was presented to County Council on 18 September 2014 by Councillor Richard Jackson on behalf of residents requesting a residents' parking scheme.
- 45. As in many locations, the County Council has an on-going programme of review and proposed changes to on-street parking restrictions in Beeston and Chilwell. This has resulted in several schemes being introduced to address existing parking issues such as new residents' parking schemes on Endsleigh and Muriel Gardens and Glebe Street, as well as junction improvements to Coventry Rd/Humber Rd junction in Beeston and parking restrictions near Attenborough train station.
- 46. We are also currently monitoring several sites following requests for parking schemes due to current levels of parking including Coventry Road, Dallas York Street, and Grove Street/Barton Street (relating to parking from the train station).
- 47. As it can be seen this Council is responding already to the many parking issues across Beeston and Chilwell.

- 48. Residents parking schemes are usually introduced in locations where availability of parking is restricted for local residents but this is not the case on Cator Lane North as all of the properties along the road have off-street parking. Cator Lane North will, however, be monitored and if necessary considered for an appropriate parking scheme in a future years' integrated transport programme if funding permits. It should also be noted that should the need arise the 2015/16 funding allocated for parking improvements will be used to address parking issues arising from NET Phase 2.
- 49. It is recommended that the lead petitioner be informed.

Financial Implications

50. Petitions may lead to schemes to be funded from a future Transport and Highways Capital Programme.

Other Options Considered

51. Each petition response sets out any other options that may be considered.
