Crime & Disorder Study Group

Final Report

Purpose of report

1 This paper presents the final report of the Community Services Select Committee's scrutiny review of Crime and Disorder for consideration by the Cabinet.

Background

- At its meeting on 3 October 2005, the Community Services Select Committee initiated a study into the effectiveness of the Crime and Disorder Team in the Youth Service.
- The attached final report was considered by the Community Services Select Committee on 8 May 2006. The Select Committee supported the recommendations in the report and referred it to Cabinet for discussion and approval.
- There are ten recommendations contained within the report (the reasons for them can be found in the Findings section commencing on page 2 and the recommendations themselves can be found on page 5).
