PLAN****Purpose of the Report**

1. The purpose of this report is to:
 - a) Provide an update on the work the Council and its partners are undertaking in relation to the COVID-19 crisis Economic Recovery Action Plan 2020-2022, as well as the impact of the various Government schemes to support businesses, being delivered through different routes including HMRC, the British Business Bank and the district authorities;
 - b) Allow Members to consider whether there are further actions required in relation to the progress on the COVID-19 crisis Economic Recovery Plan.
 - c) Enable Members to request routine progress updates for future Committee dates.

Information

2. Launched in September 2020, the COVID-19 crisis Economic Recovery Plan outlines an ambitious plan to supercharge the Nottinghamshire economy in the wake of COVID-19. Nottinghamshire County Council recognised its role in helping repair the immediate economic and social damage brought about by the pandemic. The Council instigated swift and decisive action to ensure a post COVID-19 Nottinghamshire will be more digital, greener and resilient to both current and forthcoming challenges.
3. The COVID-19 crisis Economic Recovery Action Plan contains an unprecedented package of measures to be delivered by partners locally and nationally. These measures will restore business, boost consumer confidence and provide support to those who have lost their jobs. This plan reflects local circumstances and priorities in different areas and ensures that the Council does not take a one size fits all attitude.
4. Nottinghamshire County Council continues to make rapid progress in achieving the aims set out in the Recovery Action Plan. Since the launch of the COVID-19 crisis Economic Recovery Action Plan, over £11,403,000 of new money has been secured to help stimulate the economy and directly impact the residential and business community of Nottinghamshire. A progress update, based on the six themes of people, business, visitor economy, infrastructure, digital connectivity and place, is provided in **Appendix A**.

Action the Council and its Partners are Undertaking

5. Work has continued at pace in terms of the actions outlined in the COVID-19 crisis Economic Recovery Action Plan. Key highlights include:
- A new Employment and Skills Brokerage Platform – the Council is in the first stages of procurement for a digital platform which will be the go-to-place for Nottinghamshire job seekers, returners, those looking to increase their skills and for employers looking to recruit
 - The new Digital Innovation Centre will benefit from £592,000 from the Getting Building Fund which will be used to comprehensively upgrade the existing digital IT infrastructure of the centre, boosting the productivity of the more than 40 businesses already on site, and creating new high-skilled jobs
 - The £4.3M Warm Homes Hub programme continues to be rolled out across the County. 43 households are in the pipeline and this programme has already helped residents save an estimated £90,000 in the last quarter
 - Since the launch of the employment and skills portal there have been 902 unique users of the portal
 - The transfer of Council Levy funds to its Apprenticeship Training Agency to support the employment of further apprenticeships, with a focus on supporting Looked After Children, Care Leavers and other vulnerable groups of young people and adults. Approved to date are 33 apprenticeships with a levy transfer value of £468,500 (a 45% increase since last reported to Members)
 - The Council's Business Advisers have continued to engage with Nottinghamshire businesses. 422 individual Nottinghamshire businesses have been the subject of intensive and on-going professional advice over the past 12 months. A further 403 Nottinghamshire businesses have participated in at least one of the webinars available via an extensive programme over the past 12 months gaining knowledge and direction from over 2900 hours of expert input.
 - The Council has been identified as a 'lead authority' in developing a submission for the UK Community Renewal Fund (UKCRF) which principally offers revenue funding towards projects addressing skills, local business development, challenges within communities and place and supporting people into employment. The government has identified the areas of Bassetlaw, Mansfield and Newark and Sherwood as 3 of 100 priority areas nationally for support.
 - **Appendix A** sets out in more detail the actions which have been undertaken and are underway.

Reasons for Recommendations

6. The Council recognises the need to be agile in its approach, to enable a switch from recovery to response mode and to respond to potential issues caused by the ending of Government support packages. The COVID-19 crisis Economic Recovery Action Plan is a 'live plan' with the Council responding to changing circumstances and the latest business intelligence. It is important that Members continue to monitor the situation, identify priorities and adapt so that Nottinghamshire thrives in the future.

COMMUNITY INFRASTRUCTURE LEVY – FUNDING PRIORITIES

Purpose of the Report

1. To consider the current position with regard to receipts of the Community Infrastructure Levy (CIL) in Nottinghamshire and to confirm the County Council's support for the projects as identified in the report to be funded through CIL as a priority.

Information

2. The Community Infrastructure Levy (CIL) is a charge which can be levied by local planning authorities on new development in their area in order to fund projects of strategic or district wide significance. New development which creates net additional floor space of 100 square metres, or more, is potentially liable for the Levy. S106 or planning obligations, continue to be collected for site specific infrastructure and included in a legally binding agreement which forms part of a planning permission.
3. CIL only applies in areas where a local authority has an approved charging schedule which sets out its levy rates. There are presently four authorities in Nottinghamshire operating a CIL. In chronological order of adoption these are Newark & Sherwood District Council (adopted in 2011), Bassetlaw District Council (2013), Gedling Borough Council (2015) and Rushcliffe Borough Council (2019).
4. The Government has proposed through its "Planning for the Future" White Paper, to replace the Community Infrastructure Levy and Section 106 system with a new Consolidated Infrastructure Levy. Details of how the Levy would operate, including how this would be set and collected, are yet to be published, but it is anticipated that this will have an impact on the County Council's approach to securing developer contributions in the future. Details of these proposed changes will be brought to the Committee when known.
5. Developer contributions collected through the CIL are intended to fund strategic infrastructure that is required to meet the future growth needs of the area rather than site specific mitigation that would usually be secured through a planning obligation (i.e. Section 106 Agreement).
6. A proportion of CIL receipts are passed to parish councils to fund local infrastructure and is set at 15% of receipts (or 25% where there is a Neighbourhood Plan in place). This funding is known as the neighbourhood portion and cannot be used towards strategic infrastructure.
7. Details of the strategic infrastructure items that the charging authority intends to fund either partly or wholly through the CIL are set out in its annual Infrastructure Funding Statement

(which replaced the Regulation 123 List in December 2020). In Nottinghamshire, this has mainly comprised strategic highway schemes and secondary education provision.

8. The total amount of funding retained at the end of the year for strategic infrastructure is detailed in the District/Borough Infrastructure Funding Statement (IFS) for 2019/20.

Bassetlaw

9. The list of projects which may be funded wholly or partly through CIL is set out in the District Council's IFS and includes improvements to key junctions / roundabouts in Worksop, Retford, Tuxford and Harworth, as well as expansion of secondary education provision in both Worksop and Harworth & Bircotes. The full list of highways schemes is available at Appendix A.
10. The total amount of CIL receipts held at the end of the 2019/20 financial year was £5,492,715.
11. The County Council has already drawn down funding towards the completed scheme at the A57/B6041 Gateford Road roundabout in Worksop. Design works are also underway with respect to schemes at the A57/Claylands Avenue and A60/A619 roundabouts in Worksop.
12. To date, no funding has been committed to secondary education projects in the District. The County Council is seeking to address school place sufficiency issues at Outwood Portland Academy in Worksop where a feasibility study has been conducted to identify the potential of delivering an additional two forms of entry (300 places).
13. The County Council is also conducting a feasibility study with regards to a proposed expansion of primary and secondary provision at Serlby Park Academy in Harworth, however the additional secondary places (which would be CIL funded) are not expected to be required for several years, and will depend on the delivery rate of recently permitted housing developments.

Gedling

14. The list of projects which may be funded wholly or partly through CIL is set out in the Borough Council's IFS and includes the following three items: construction of the Gedling Access Road (GAR), additional secondary school provision associated with the Gelding Colliery / Chase Farm and Top Wighay Farm developments, and the Gedling Country Park Visitors Centre.
15. The total amount of CIL receipts held at the end of the 2019/20 financial year was £1,276,677.
16. Since Gedling Borough Council first adopted the CIL, the strategic portion of CIL receipts have been ring-fenced for the construction of the Gedling Access Road (GAR). CIL receipts for the strategic element will continue to be ring-fenced for this piece of infrastructure whilst there is a continued need for the funding. The Borough Council has agreed to contribute up to £4.48 million as stated in its December 2020 Infrastructure Funding Statement.
17. The Borough Council's Statement also confirms that, once the funding gap for the GAR has been addressed, the following priority will be the delivery of secondary school facilities associated with the Gedling Colliery / Chase Farm development. The County Council has invested approximately £3m in providing additional places at the Carlton Academy and would seek to recover this expenditure through CIL, if future CIL receipts allow. However, it is acknowledged that the current proposals to reform CIL / S.106 may impact on future reliability of this revenue.

Newark & Sherwood

18. The list of projects that may be funded wholly or partly through CIL is set out in the District Council's IFS and includes the delivery of major highways schemes such as the widening of the A1 Overbridge at Fernwood and the installation of the Kelham Bypass, as well as improvements to key junctions across the District. The list also includes the delivery of additional secondary education provision within the District. The full list of highways schemes is at Appendix B.
19. The total amount of CIL receipts held at the end of the 2019/20 financial year was £5,146,605.
20. The widening of the A1 Overbridge remains the District Council's highest priority, given its need as part of the Fernwood development highways mitigation strategy. NSDC is therefore working with Highways England to develop a detailed project brief. The estimated cost for the work is expected to be in the region of £5.2 million according to NSDC's IFS.
21. NSDC has also committed £620,000 towards the delivery of a two storey, four classroom expansion of Joseph Whitaker School in Rainworth. The project is being delivered by the East Midlands Education Trust and will help address the projected deficiency of secondary school places in the Rainworth Planning Area. There are currently no other sufficiency issues or plans to increase capacity at other secondary schools in this District.

Rushcliffe

22. The list of projects that may be funded wholly or partly through CIL is set out in the Borough Council's IFS and includes provision of a Park & Ride along the A52 corridor and bus priority measures in West Bridgford, improvements to playing pitches and leisure facilities, and the provision of new/extended secondary education and health facilities across the Borough.
23. Due to the time at which CIL was adopted within the Borough, no developments incurring a CIL charge were commenced during the last financial year. Therefore, the total amount of CIL receipts retained at the end of the 2019/20 financial year was £0.00.
24. The County Council is working with several Academies to progress projects to increase secondary education capacity in the Rushcliffe East and West Bridgford Planning Areas. Further funding may be sought through CIL to supplement existing funding for secondary education provision in the future.
25. As funding accrues, NCC will work with RBC to support delivery of the proposed public transport improvements along the A52 Corridor and in West Bridgford.

1. This report seeks Members approval and support for the applications submitted by Nottinghamshire County Council (NCC) to the Natural Environment Investment Readiness Fund (NEIRF). The report also seeks agreement from Members to provide additional supporting documentation in relation to the four applications if requested by the Environment Agency. Finally, the report seeks approval to undertake a procurement process should the bids have a successful outcome.

Information

2. The Department for Environment, Food and Rural Affairs launched the Natural Environment Investment Readiness Fund (NEIRF) to explore how to bring forward greater private investment into natural assets, alongside public investment. This is to take advantage of a growing demand to invest in green financial markets, with potential for public sector savings and a share of profits to be re-invested into the public purse.
3. This fund will provide grants of £10,000 to £100,000 (inclusive of VAT) to pay for technical and specialist market advice. The purpose is to take learning from environmental projects and inform new investment models to help fund future environmental interventions. This will explore how the private sector can be supported through financial markets in a way that increases benefits for the public and private sector. This exploratory work into green finance must be associated with the delivery of a funded environmental project delivered within two years and capable of being applied at scale to other places in the future.
4. Projects must support the 25 Year Environment Plan, for example, with outcomes for green places:
 - i. sustainable UK developments including improving the quality of urban developments, non fossil-fuel energy and preventing flood risk;
 - ii. growth in sustainable supply chains. For example, off-site manufacturing in construction, sustainable forestry, carbon offset industries;
 - iii. protecting environments of public value and increasing biodiversity and improving the future quality of our air, water and food supplies.
5. Our current sites meet the above criteria and offer unique opportunities to set a national benchmark for building greener to safeguard our natural environment. The project also provides scope to support mental health, the visitor economy and

employment outcomes.

6. The work will support the County aims to deliver a green recovery in the wake of the Covid-19 pandemic and will help the Council strive towards an ambitious future to benefit all residents. This work will also enable us to lead the debate on how public and private finance can be best applied at scale towards environmental and placemaking interventions, including feeding directly into Government's Green Finance, Planning Reform, Green Growth and Infrastructure funding agendas. If successful investment models are identified, then there is scope to scale these up via external partners who support the project.
7. Following approval officers explored the potential application of this fund, collated evidence and submitted bids. Four applications were made on the 29th March and are currently undergoing consideration. Each application covered a separate, ambitious investment model to be explored.

I. Green Transport Options: Green & Active Investment Models

Green and sustainable transport will be a focus across several sites. The fund will help develop models to support benefits to all for investing in ecosystem services at sustainable transport locations. This will boost biodiversity, improve water and air quality and support environmentally friendly travel for work and leisure. This application requested £100,000 in grant funding.

II. 5G Connected Forest: Investment models for the new 5G Technologies

Exciting 5G technologies are currently being piloted in Nottinghamshire with the 5G Connected Forest Programme. This application requested £100,000 in grant funding.

III. Low Carbon Buildings: BREEAM Investment Models

The County Council is developing high quality environmentally beneficial buildings across our estate including; social housing decarbonisation, meeting head on the Government's challenge to build back greener and better. This fund will enable models to be explored that can both invest in and generate funds to serve commercial and public needs for clean air, water & energy in urban habitats. This application requested £100,000 in grant funding.

IV. Investigating investment models at landscape scale in Sherwood and Trent Valley

The model will seek to identify the current market factors influencing investment decisions in the Sherwood, Trent Valley Washlands and Trent & Belvoir Vales National Character Areas in Nottinghamshire. This fund will help identify opportunities for re-purposing existing investment mechanisms and attracting new forms of investment to deliver habitat restoration and re-creation on a planned basis at a landscape scale. This application requested £87,625 in grant funding.

8. Internal and external partners were engaged on the potential investment models and provided letters of support. They have agreed that if funds are awarded to NCC, they will collaborate to develop and support NCC's exciting vision for a green and sustainable future. Key stakeholders include D2N2 LEP, Midlands Connect, Greenwood Community

Forest, Local Universities and East Midlands Chamber.

9. The proposed applications are currently being sifted by the Environment Agency. The NEIRF Project Board will then assess the content of the bids and will decide on the outcome. The Board may request further detail over the assessment period. The outcome is expected to be announced in **July 2021**. Annex A outlines a breakdown of quarterly milestones should the bid outcome be successful.

Other Options Considered

10. To not approve the use of additional resource from this fund would impact on the Council's ability to explore the opportunities presented by green finance.

Reason/s for Recommendation/s

11. In order for the Committee to continue to support the progress of our application and endorse that Officers' undertake a procurement process in respect of the fund as quickly as possible should the funding application be successful.

Interdependencies

12. This grant funding only requires NCC to share the learning outcomes of the project report commissioned. It does not create any obligation to engage with any finance model in return for the fund and does not commit NCC to success or implementation of the investment model(s) explored.
13. The total value applied for each project was justified based on an estimate of the cost for market specific advice. NCC may be asked to obtain detailed quotes and a specification of the procurement for the work if funding is awarded. Any commission would seek to maximise value for Nottinghamshire County and for DEFRA. Some claim back has been requested for project administration; up to 20% of the fund may be claimed against evidenced and justified staff salary. It is proposed that for any projects awarded, this could be re-invested into supporting research to achieve the Fund outcomes.

Statutory and Policy Implications

14. This report has been compiled after consideration of implications in respect of crime and disorder, data protection and information governance finance, human resources, human rights, the NHS Constitution (public health services), the public sector equality duty, safeguarding of children and adults at risk, service users, smarter working, sustainability and the environment and where such implications are material they are described below. Appropriate consultation has been undertaken and advice sought on these issues as required.

Financial Implications

15. This report highlights a bidding process for a potential £387,625 to be made available for the four proposed investment models. No match funding will be required, but it can be used should the opportunity arise. S151 officer approval will be sought for any funding that is secured (in line with Constitutional requirements).

RECOMMENDATIONS

It is recommended that Economic Development and Asset Management Committee:

- 1) Provide endorsement of the four proposed applications.
- 2) Agree to Officers providing any additional supporting documentation if requested by DEFRA in relation to the four proposed applications.
- 3) Agree to Officers undertake a procurement process should the bids have a successful outcome.

FOR PEOPLE AND PLACE' PROJECT****Purpose of the Report**

1. This report seeks to provide Members with background information on the River Trent Partnership; and seeks support for the submission of an Expression of Interest by the Environment Agency to the MHCLG 'Partnerships for People and Place' project.

Information

2. Nottinghamshire County Council is exploring with the Environment Agency and other regional partners, the potential to form a new catchment wide partnership that will deliver both economic and environmental gains known as the River Trent Partnership (See Annex A). The Partnership will focus on pooling resources to take better advantage of funding opportunities, in particular those arising from the Government's National Infrastructure Strategy.
3. On 25th November 2020, the Chancellor set out Spending Review 2020 and published a National Infrastructure Strategy. He also announced plans for a new infrastructure bank to catalyse private investment in projects across the UK. In total the Spending Review will deliver £27bn devoted to transport, energy and digital communications infrastructure in 2021-22. The Treasury has also updated its Green Book guidance on investment decisions to include taking into account wider policy objectives such as levelling up the UK and achieving net zero and up to 250,000 UK green jobs. The National Infrastructure Strategy will allocate funds from an interdepartmental budget.
4. The Environment Agency have approached Nottinghamshire County Council with a view that the authority would have a key leadership role in the formation and co-ordination of the River Trent Partnership (RTP). This work aligns closely with County aims to deliver a green recovery in the wake of the Covid-19 pandemic and will help the Council strive towards an ambitious future that will unlock the full economic potential of the catchment area.
5. Local authorities and LEPs have been contacted to gather information to build a vision and baseline for the RTP. This work involves analysing the partners strategic priorities, understanding the type of projects that are planned and confirming baseline metrics of the economic value to be harnessed through environmental interventions across the catchment. Terms of reference for the partnership are currently being developed. This

will put the partnership in a strong position to approach the Environment Agency for funding towards further business case development and to identify priority projects across the catchment.

6. The River Trent Partnership seeks to learn from the recent success of the River Severn Partnership which was able to secure millions of pounds of funding from DEFRA and the Environment Agency, based on demonstrating the economic benefits of alternative flood defence interventions. The River Trent Partnership vision will aim to go further than flood defence potential in order to access other areas of budget within the National Infrastructure Strategy.
7. One source of funding for the partnership is the MHCLG 'Partnerships for People and Place' project. This project is focused on 'place-based' initiatives which are defined, informed and delivered locally through collaboration to develop inclusive and flexible local solutions. The learning from this can then be applied to any other place facing similar issues. This project has the backing of the Treasury-funded Shared Outcomes Fund to analyse the interventions and impacts of 'place-based' policies in up to 15 pilot places in England. Results from the pilot projects will be shared across all government departments to shape the national Levelling Up policy.
8. The Environment Agency on behalf of the partners in the River Trent Partnership are seeking to submit an expression of interest to the 'Partnerships for People and Place' project in June. The Shared Outcomes Fund will help the partnership achieve strategic alignment across local delivery partners and will ensure that communities across the pan-regional catchment area will be supported to have the same levels of accessibility to quality services. MHCLG will use the expression of interest process to identify potential pilot places for funding in July.

Other Options Considered

9. To not work at this catchment wide scale will make it difficult to enable new outcomes and access funding opportunities which can only be unlocked through this partnership. This is an opportunity for the County Council to shape regional agendas which would be lost if the County Council did not take a lead role.

Reason for Recommendation

10. In order for the Committee to provide support for a bid for funds to support place based initiatives under the RTP.

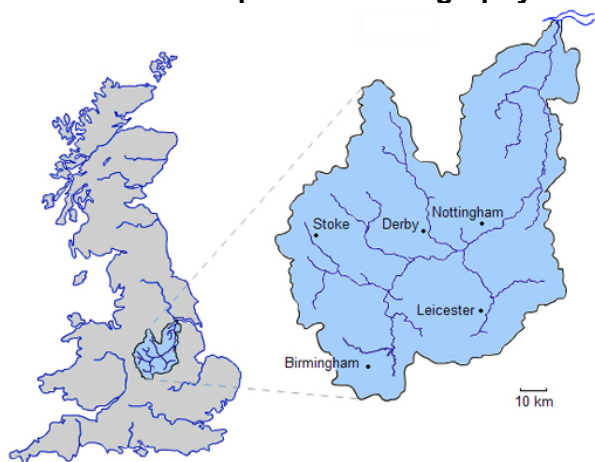
