The Nottinghamshire Family and Parenting Strategy and action plan (2015-17) recognises that the task of local services is to provide the best support to enable parents to ensure their families welfare. Central to this is providing co-ordinated, consistent support, so that families can be safe, happy and secure.

The Family and Parenting Strategy has been written in a time of reduced resource and aims to ensure that families receive cost-effective, appropriately targeted support. The strategy has also been informed by wide range of partners and drawn on a number of existing consultations with parents and also academic evidence of what works in parenting support.

To this end, the impact of the strategy should be positive for children and families in the following ways;-

• By ensuring that agencies take a co-ordinated multi-agency approach to planning and delivering parenting support, we will reduce duplication and ensure that families get the right support at the right time. We will improve families experience and journey through our services through a more streamlined approach.

- By influencing commissioners to commission evidence based support , we will ensure that we are only offering families services that are proven to work
- By involving families in the planning, design and delivery and evaluation of support, we will be better able to respond to family's needs, empower parents and carers and provide services that families want to engage with.
- By ensuring that services are available for target vulnerable groups, we will ensure that those in the greatest need receive appropriate, responsive services.

Overall, our approach will ensure that limited resources are spent in a way that benefits families and targets need effectively.

The proposed changes will have no negative effect on service users with protected characteristics and will, if anything have a positive effect as those in the greatest need will be targeted most effectively.
