## Summer Safety

### Keeping Safe Over Summer

With the summer holidays fast approaching it is time to remind ourselves of the need to encourage our young people to keep safe in their free time.

We have identified some very good information provided below to share with pupils and parents/carers before the end of term. Please include in any correspondence you send home or include on your school website/parents' page.

### Hot Weather Advice Water Safety

The recent deaths of young people from drowning has highlighted again the dangers of swimming in hot weather. It is perfectly natural to want to cool off when it's hot but rivers and quarries hide dangers below, and the additional hazards of freezing cold water and currents can result in tragedy. Teenagers especially can be drawn in by peers and can be more likely to participate in risky behaviours. Some of these resources might be helpful for assemblies or tutor sessions.

### Sun Safety

The Teenage Cancer Trust found that nearly two-thirds (61%) of young people aged 13-24 have avoided using sunscreen in order to get a better tan. As the weather gets hotter in the UK, we need to be more knowledgeable about keeping safe in the sun than ever before.

The damage done to young skin can lead to skin cancer developing in later life, so it's vital to help young people protect themselves in the sun.

**Advice for Parents / Carers**

- Make sure matches and lighters are stored out of sight and reach of children and young people.



- Never leave children or young people alone in the house, even for short periods of time.
- Search for lighters and/or matches in bedrooms and school bags.

- Keep outbuildings, garden sheds and garages locked to prevent access to flammable materials.
- Explain to the child or young person that matches and lighters are not toys.
- Explain to children that fires can hurt and kill.
- Make sure the home is fitted with smoke alarms. A smoke alarm will quickly alert you to any fire-setting activity.
- Make a fire escape plan with your family and practice it.



**How to make a referral**

If you think the problem is serious or you cannot deal with it on your own, seek help.

**Why?**

Most children and young people show a natural interest and curiosity in fire.

Even if they do not display any fire-setting behaviour, many children and young people may be fascinated by fire - the glow from a real flame, blowing out their birthday candles, or even watching an adult light up a cigarette. It is not uncommon for children as young as two years of age to show an interest in fire. However, for some young people this interest develops into something more dangerous.

Without help and guidance, fire-setting behaviour can become increasingly serious and lead to injury, damage to property and tragically, death. Please read this leaflet and act on its advice. You could reduce the chances of your child or young person starting a destructive fire.

**What the programme does**

The aim of the programme is to help children and young people understand and control the feeling and circumstances that lead them to set fires.

**Interventionists**

Nottinghamshire Fire and Rescue Service has a dedicated team trained in the delivery of the Firesetters programme, which is partnered with Fire and Rescue Service experience to achieve excellent results.

**What is involved?**

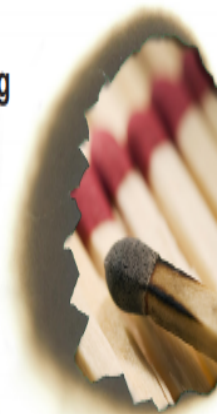
The aim of the first visit by the Firesetters team (they always work in pairs) will be to find out more information about the child or young person involved and to establish a trusting relationship.

The number of visits we make, and the precise way in which we deal with the child or young person, will vary depending on the circumstances and issues involved. The team will be available to answer any questions throughout the process.

**Tell-tale signs of regular fire-setting**

- Small burn holes in carpets, beds and/ or furniture.
- Charred paper in sinks or wastebaskets.
- Matches or lighters hidden in your child's cupboards and drawers or under their bed.
- An unusual fascination with fire.
- Unexplained fires in your home.

Early recognition and confrontation of this behaviour through a Firesetters referral can ensure it does not continue into adulthood.



## Nottinghamshire Women's Aid Ltd: TIP Service

---

**This is a service for children and young people who have witnessed domestic abuse and violence where a weapon has been used.**

This service is funded by the Violence reduction Unit until March 2022. TIP refers to the TIP of an iceberg; where there may be visible things on the surface, but much more to uncover beneath. This service offers 1-1 support for children and young people between the ages of 5-18 who have witnessed domestic abuse in the home where a weapon has been used. A weapon may include a knife, other traditional weapons or household objects that are used for physical violence.

Support is free, confidential and can last from 4-12 weeks. Sessions are led by the young person and may cover; exploring their emotions, healthy relationships, anger, how to stay safe, and building confidence. This could be through talking, creative activities or worksheets. Sessions can be virtual, or face to face (with covid risk assessments completed).

Criteria for referral:

1. Ensure you have consent from young person and non-abusive parent/care giver
2. Live in the area (Bassetlaw, Mansfield, Newark and Sherwood)
3. Age 5-18 (At least school year 1)
4. The child/young person has memory of the abuse

## Nottinghamshire Women's Aid Ltd: Teen Service

---

***This is a service for young people who are experiencing domestic abuse in their own intimate (romantic) relationships.***

We offer 1-1 support and group work to enable young people to make informed choices around their relationships. Support plans are made with the individual and can include work around; healthy and unhealthy relationships, keeping safe, understanding emotions and processing the impact of domestic abuse.

Support is free, confidential and the length of time is flexible depending on the needs of the young person.

Criteria for referral:

- Young men and women between 13-18 (experiencing domestic violence or abuse in their relationship-either current or historic)
- Young women 18-25 (in an abusive relationship as above) ALSO with an additional vulnerability. A vulnerability may include; housing needs, LAC status, diagnosed disability.
- Consent given by young person who is aware of referral and wanting support
- Lives in our area: Bassetlaw, Newark and Sherwood, Mansfield

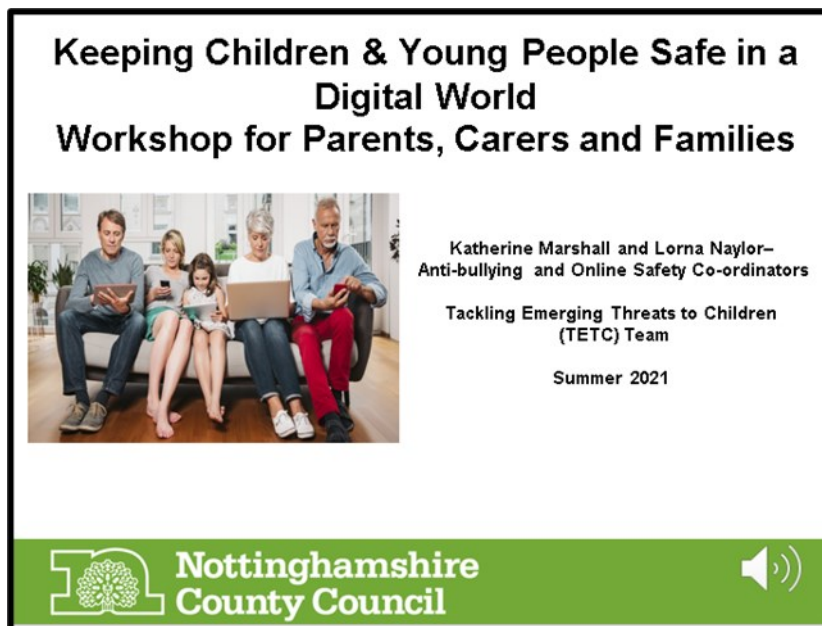

## Safeguarding in Education News Updates

---



**At the time of this TETC Newsletter going to publication:** The DfE have concluded the consultation for KCSiE 2021 on the 31<sup>st</sup> March 2021 but to date we are still waiting for the Government to publish it, and inform us of the revisions they have made to KCSiE for 2021. Once published it will not become statutory until the first week of the autumn term 2021 but it will hopefully provide us all with sufficient time to review and make revisions to our policies, procedures, guidance, and toolkits. As soon as it becomes available, I will ensure it is brought to your attention and provide a summary of key changes.

### **NCC and NSCP Child Protection Policy template for 2021-2022 and the NCC & NSCP Safeguarding in Education Audit Toolkit for 2021-2022**

When KCSiE 2021 becomes available I will revise both of the above in line with the revised national statutory safeguarding guidance and our local Nottinghamshire Safeguarding Children Partnership (NSCP) policies and guidance. I hope to get both ready and published in sufficient time for you to be able to use and adopt them to review and quality assure your schools 'safeguarding arrangements'.

**Nottinghamshire Safeguarding in Education Annual Self –Check Audit** (previously known as Annual Governors Compliance Checklist) for 2021/2022 remains a statutory requirement for all schools, academies and educational establishments to engage with and complete, to ensure appropriate and robust 'safeguarding arrangements' are in place to keep children safe. The audit reflects the statutory guidance contained within the Department for Education's Keeping Children Safe in Education (KCSiE), HM Working Together to Safeguard Children 2018 and the Nottinghamshire Safeguarding Child Partnership (NSCP) safeguarding arrangements.

When completing the audit please ensure your SiE audit checklist form has sufficient evidence from your school or academy's practice so that it can be signed off at the first full governing body meeting of the autumn term 2021 and record the evidence of completion within the full governing body or trust minutes. Ofsted will inspect the 'safeguarding arrangements' you have put in place as part of the leadership and management arrangements of your school, academy or college.

**NCC Safeguarding Children in Education Whole School Child Protection Policy Template 2021/2022.** NCC is required to provide a Child Protection Policy template framework which reflects and adopts statutory guidance from the DfE KCSiE 2021, HM Working Together to Safeguard Children 2018 and the local Nottinghamshire Safeguarding Children Partnership Policy and Practice Guidance. It is then for each school, academy, college or educational setting to make their own 'safeguarding arrangements'.

**Please Note:** DfE KCSiE states; Head teachers, Governing bodies and proprietors should ensure there are appropriate policies and procedures in place in order for appropriate action to be taken in a timely manner to safeguard and promote children's welfare.

## Safeguarding in Education News Updates (continued)

This should include:

- Individual schools and colleges having an effective child protection policy. The child protection policy should describe procedures which are in accordance with government guidance and refer to locally agreed multi-agency safeguarding arrangements put in place by the three safeguarding partners. It should be updated annually (as a minimum) and be available publicly either via the school or college website or by other means.”

**IMPORTANT:** Please ensure your school, academy or college’s child protection policy is compliant and informs of your setting’s individual arrangements to safeguard children and young people and is in place for the beginning of the autumn term 2021 and published on your school’s website.

### Reducing Parental Conflict – Renamed ‘Relationships Really Matter’ Launch of New Resource for Parents and Practitioners

A new resource for parents and professionals has been developed aimed at helping parents resolve their everyday disagreements in a positive manner, mindful of the impact that an unhappy home atmosphere has on their children. ### Reminder regarding the Pathway to Provision V 9 published March 2021

The Pathway to Provision is the multi-agency thresholds’ guidance for Nottinghamshire and provides information for practitioners to help them understand the needs of children and young people and identify the services that are available to meet those needs.

The guidance has recently been updated and is available on the Nottinghamshire Safeguarding Children Partnership (NSCP) website.

**Launch of the Cross-Authority Child Neglect Strategy for 2021-2024** Nottinghamshire Safeguarding Children Partnership launched its new Child Neglect Strategy at the Partnership Forum on 18<sup>th</sup> May 2021. The Strategy has been developed jointly with Nottingham City and sets out what the Partnerships intend to do over the next 3 years to prevent neglect and minimise its impact. The Strategy identifies 3 key objectives; Recognise, Respond and Reflect and Review. Shared priorities under each objective provide a focus for the work so that all partner organisations can develop their own response and contribute towards the aims of the Strategy and improve outcomes for children who live in Nottingham and **Nottinghamshire**. **A copy of the document can be accessed from the Nottinghamshire Safeguarding Children Partnership (NSCP) website link: [Nottinghamshire Safeguarding Children Partnership](#)**

### Child Sexual Exploitation (CSE) Concerns Network Information – Operation STRIVER

Operation Striver has been in existence in Nottinghamshire since November 2013. The aims of Operation Striver are:

- To establish a network of multi-agency professionals who can share low level, non-emergency intelligence / information with the police
- Police to then share appropriate intelligence with agencies or intelligence to be used to disrupt activities, develop a 'problem profile' and determine policing priorities
- To ensure a proportionate response to the intelligence.

Nottinghamshire Police colleagues have advised that the amount of Operation Striver notification forms have reduced in number. However, intelligence suggests this is not because the number of incidents of concern have reduced but may be more to do with agencies, schools and other partners not making notifications of concern, along with the need to keep Operation Striver at the forefront of everyone's awareness and understanding.

I am mindful since 2013 when Operation Striver was first introduced in Nottinghamshire, we have seen a significant number of changes to senior leadership teams in Schools, Academies and Colleges and to those with Designated Safeguarding Lead status.

#### **Safeguarding - The Wood Review**

A new report on the implementation of new multi-agency arrangements to safeguard children by Sir Alan Wood CBE has been published on 14<sup>th</sup> May 2021. The review sets out recommendations for making new multi-agency safeguarding arrangements for local areas more effective.
