I would like to make a request for some data you hold as the STP Lead, FOI lead or contact for a CCG leading an STP.

I would like to request:

- any data you hold on how much your STP has spent on management consultancy fees or contracts since the STP was created broken down by month or year (whichever is available most easily).
- any planned expenditure on management consultancy fees for 2017-18.

This would include any member organisation spend dedicated solely to STP activities, but please indicate if these have come from CCG, other NHS, PHE, local authority or other funds. I am looking at long term trends across the NHS on management consultancy spends and the Department of Health have already supplied data on NHS Trusts, Foundations Trusts, NHS England and historical data on PCTs and SHAs. The information I am requesting from you is to ensure the data encompasses all NHS spend over time.

I am happy to discuss this or provide clarification if needed. I look forward to hearing from you.

Further to your request for information below.

The Nottingham and Nottinghamshire Health and Care Sustainability and Transformation Partnership is not a statutory body but a partnership of the six CCGs, three NHS Trusts and eight Local Authorities in Nottingham and Nottinghamshire who are now coming together to plan and deliver services across a wider geography and as an integrated health and care system. The footprint has a resident population of 1,001,600 citizens and would emphasise that it also has a total place-based spend across health and social care of £3.7 billion.
