STATUTORY DECLARATION

SECTION 31(6) OF THE HIGHWAYS ACT 1980

I ROBIN JAMES BROWN DO SOLEMNLY AND SINCERELY DECLARE as follows:

1. I am and have been since 1st August 1982 employed by The Welbeck Estates Company Limited (the Company) as Assistant Agent and since 31st March 1991 as Agent and Company Secretary for the Company in respect of the land known as the Welbeck Estate part of which is more particularly delineated on the map accompanying this declaration and thereon edged red.
2.
