AVERIL HAROLD DO SOLEMNLY AND SINCERELY DECLARE as follows:


- The Woodland Trust, a company limited by guarantee and registered charity no. 294344, is and has been since 31 December 1998 the owner of the land known as Willoughby Wood, Willoughby on the Wolds more particularly delineated on the plan accompanying this declaration and thereon edged red.
- 2. On the 26 of July 1999 the Woodland Trust deposited with Nottinghamshire County Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that:
