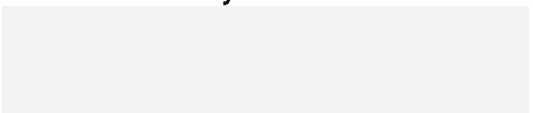



1. I am and have been since 25<sup>th</sup> March 1996 the owner of the land known as High Elm Farm, Willoughby on the Wolds, more particularly delineated on the plan accompanying this declaration and thereon edged red.


