The deposit comprises this Statement and the accompanying Plan.

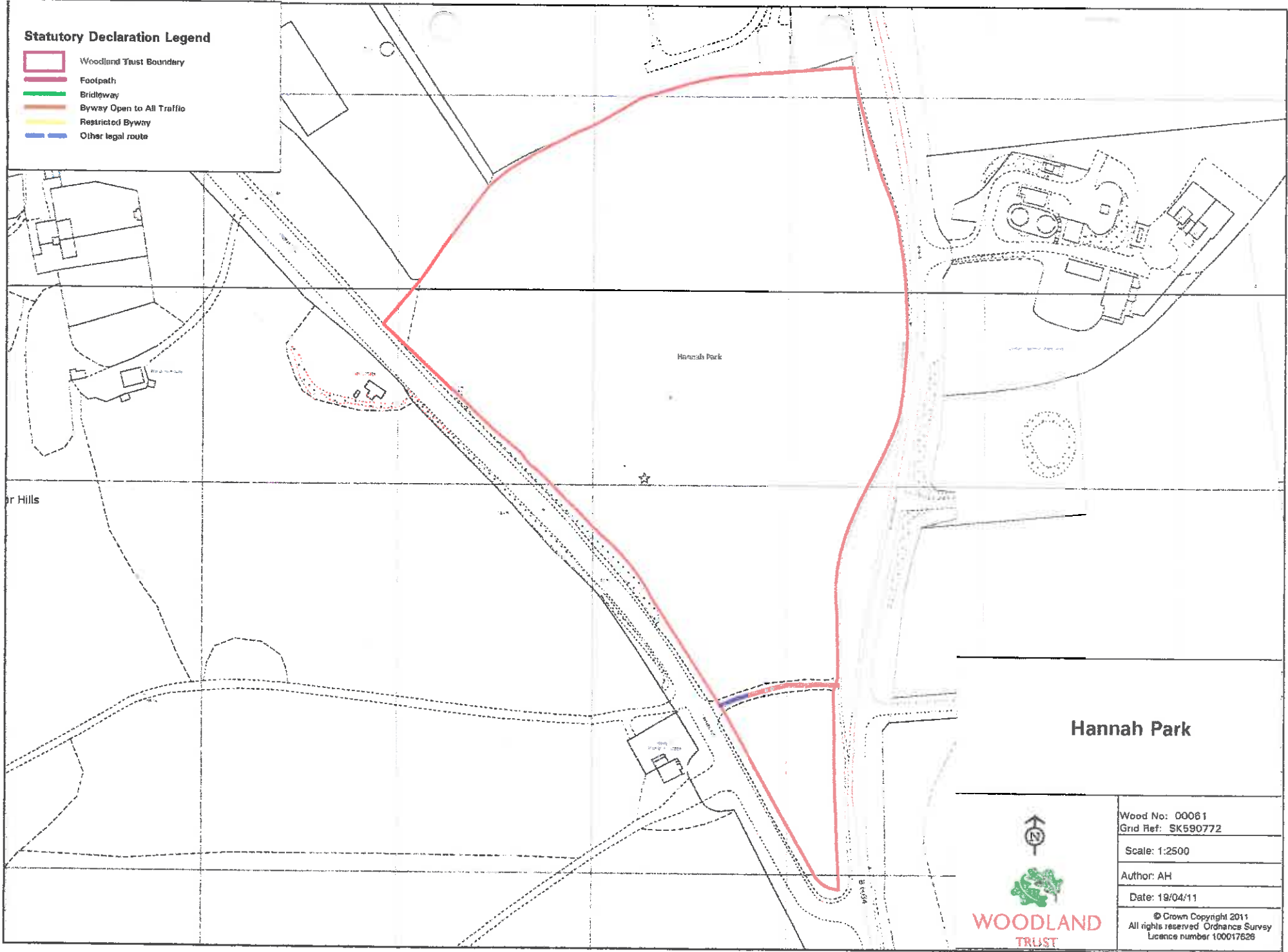
