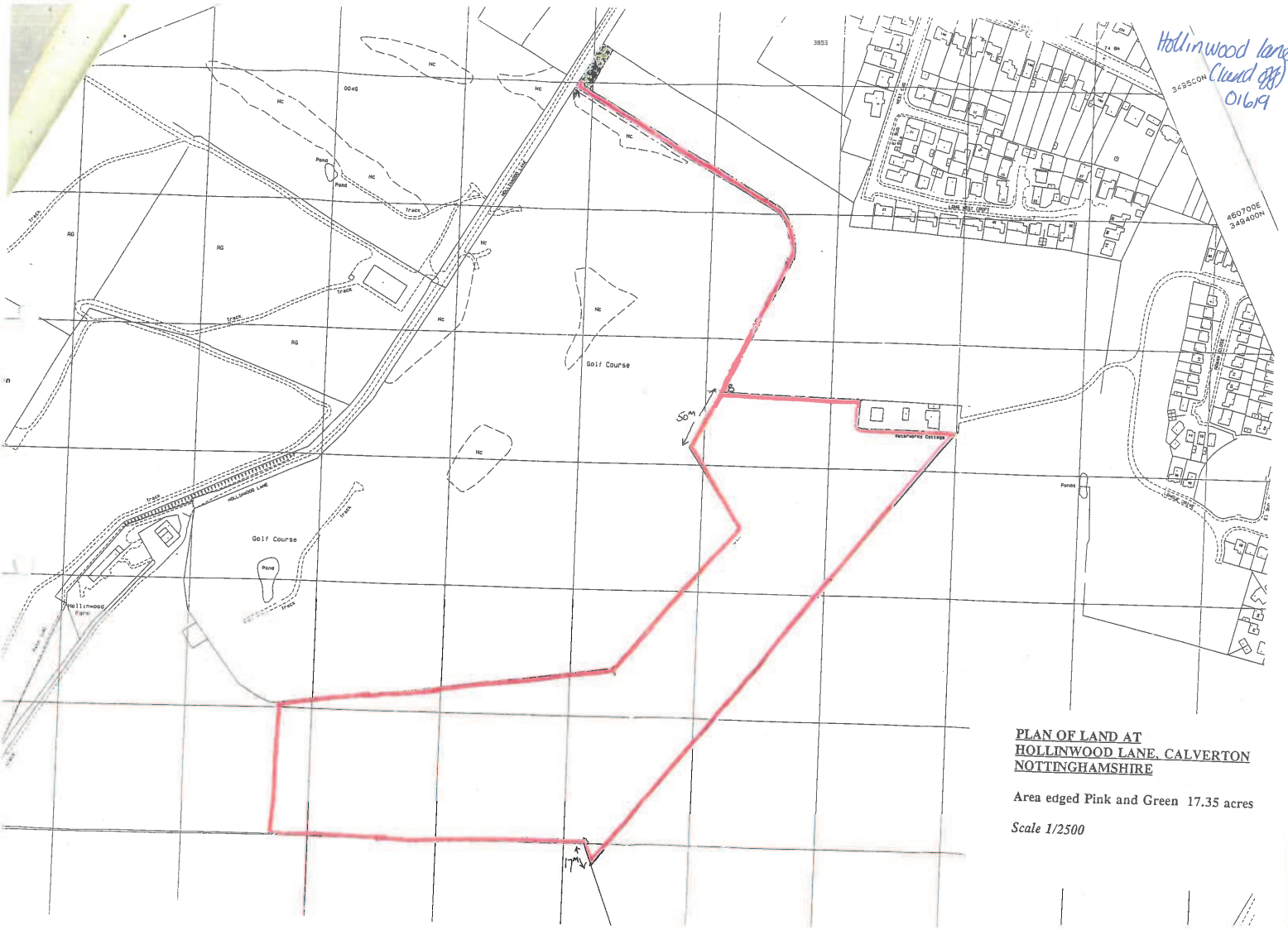
No ways over the land have been dedicated as highways.


I AVERIL HAROLD DO SOLEMNLY AND SINCERELY DECLARE as follows:
