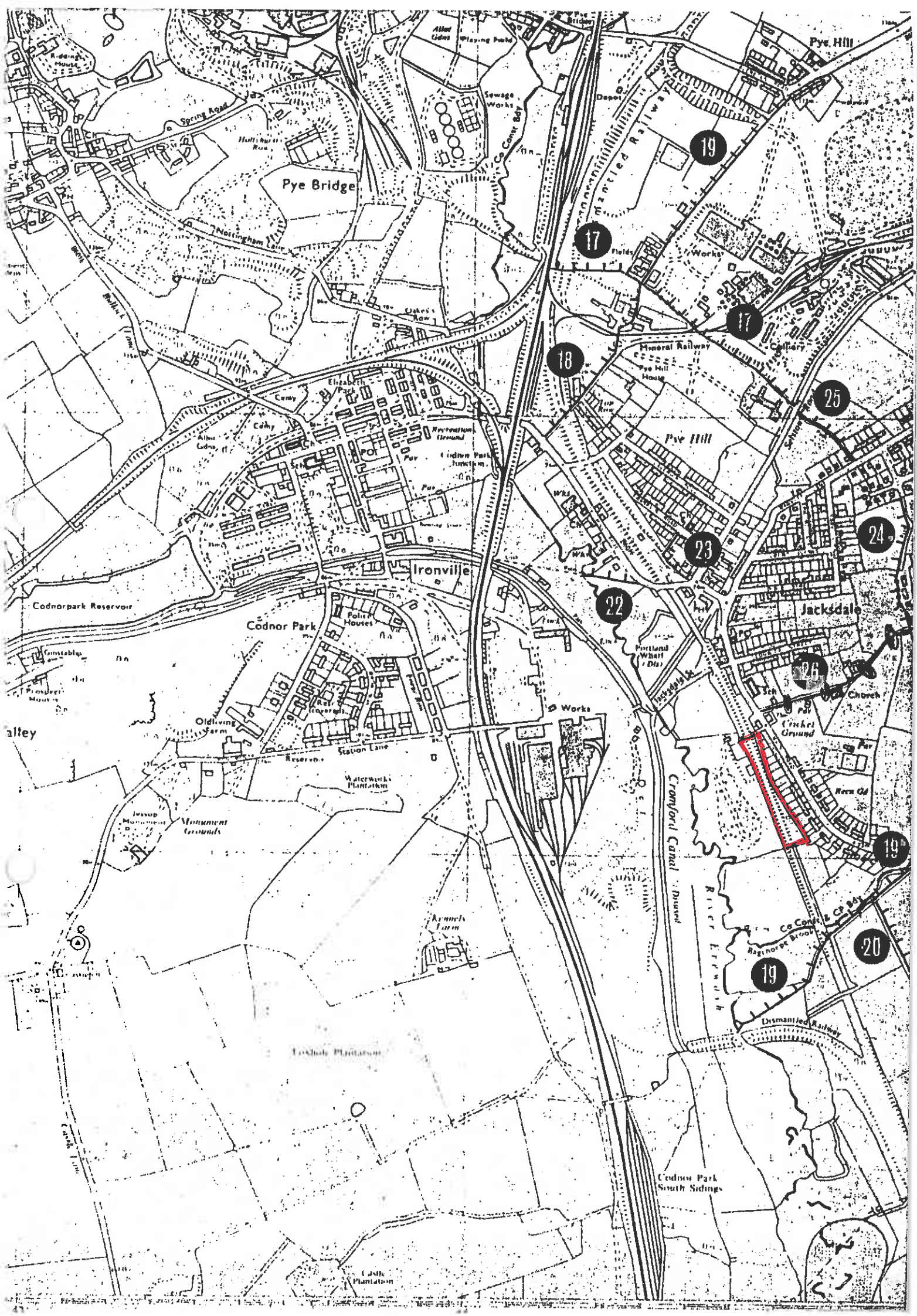

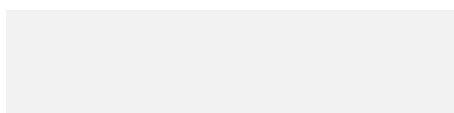

3. No ways over the land have been dedicated as highways.

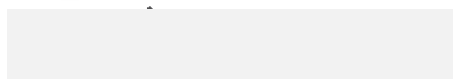
