STATUTORY DECLARATION

HIGHWAYS ACT 1980 SECTION 31 (6)

I AVERIL HAROLD DO SOLEMNLY AND SINCERELY DECLARE as follows:

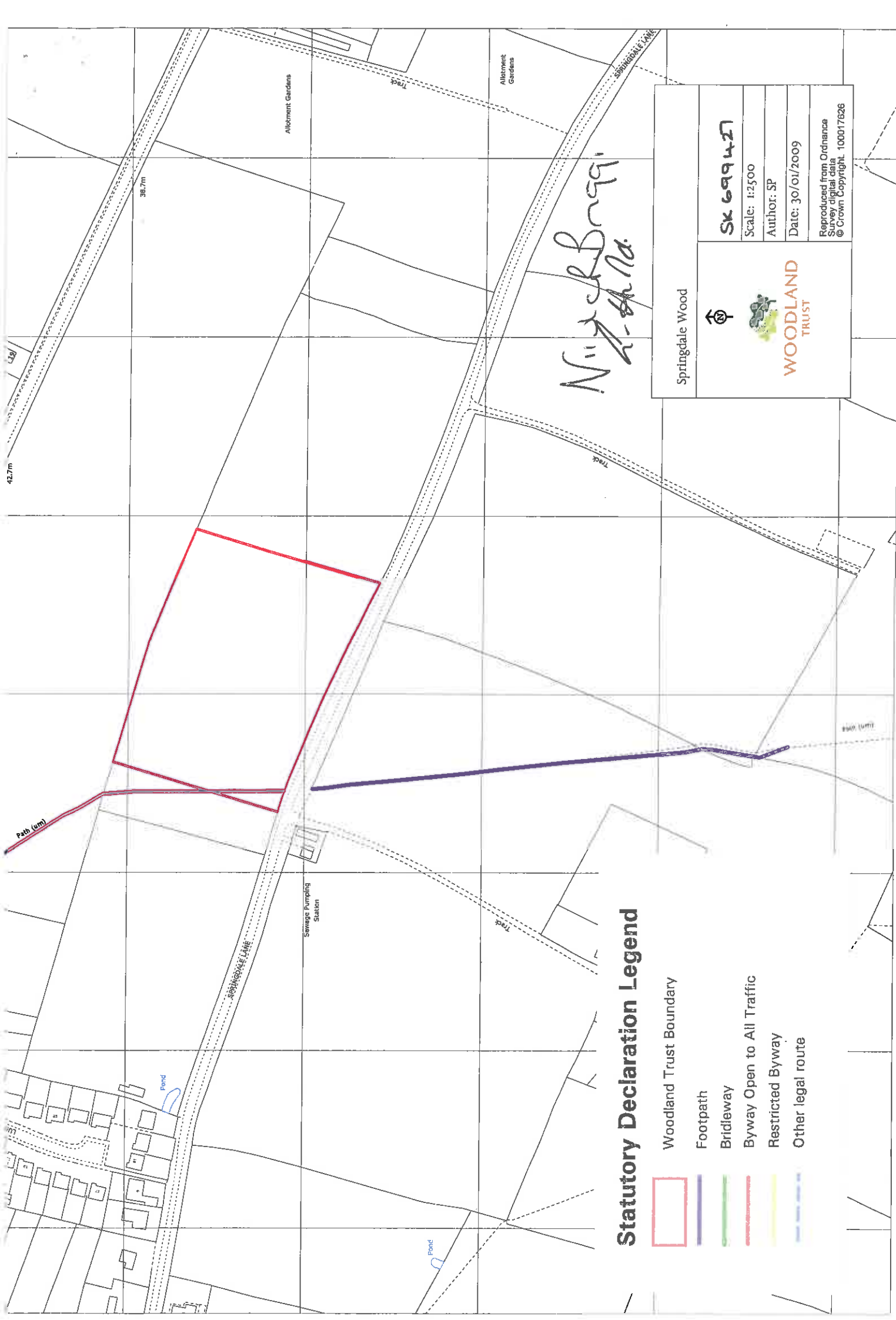
1. The Woodland Trust, a company limited by guarantee and registered charity no. 294344, is and has been since 20 January 1999 the owner of the land known as Springdale Wood, East Bridgford more particularly delineated on the plan accompanying this declaration and thereon edged red.
2. On the 26 of July 1999 the Woodland Trust deposited with Nottinghamshire County Council, being the appropriate Council, a statement accompanied by a plan delineating our property by red edging which stated that:
 - the ways coloured purple on the said plan and on the plan accompanying this declaration had been dedicated as footpaths
 - no other ways had been dedicated as highways over our property.
3. No additional ways have been dedicated over the land edged red on the plan accompanying this declaration since the statement dated 26 July 1999 referred to in 2 above [other than those footpaths marked in the appropriate colour on the plan accompanying this declaration] and at the present time the Woodland Trust has no intention of dedicating any more public rights of way over its property.

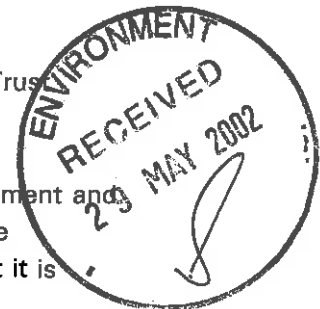

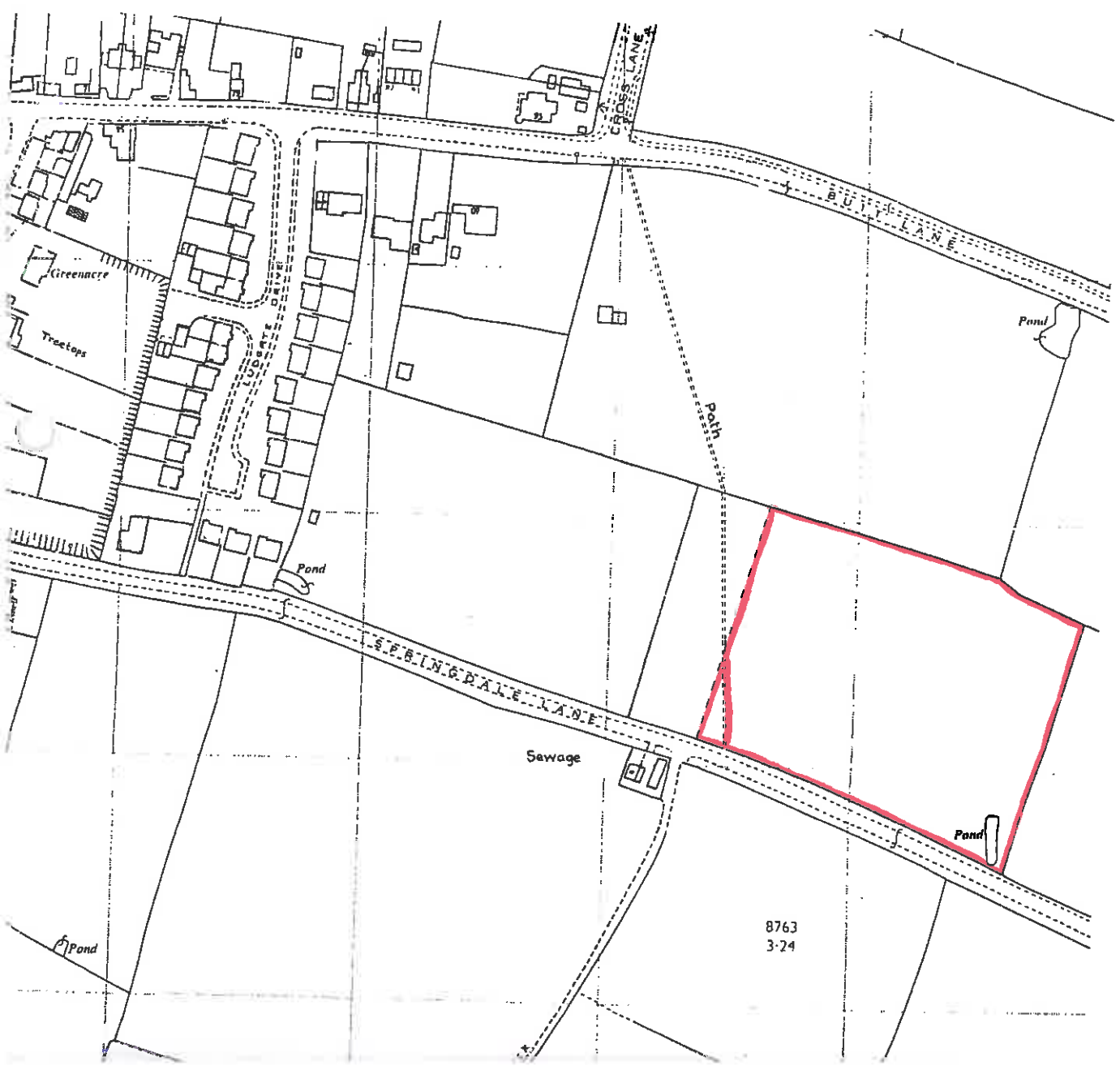
