
DO SOLEMNLY AND SINCERELY DECLARE as follows:

The aforementioned land was acquired on the sixth day of November nineteen eighty one and on the fourteenth day of December nineteen eighty one as shown on the plan. The aforementioned land extends into Rotherham Metropolitan Borough and this declaration refers only to that part which lies in Nottinghamshire

2. On the second day of May nineteen hundred and ninety seven I deposited with Nottinghamshire County Council being the appropriate Council a statement accompanied by a plan delineating the said land by red edging which stated that the ways coloured green on the said plan and on the plan accompanying this declaration are definitive BRIDLEWAYS the ways coloured purple on the said plan and on the plan accompanying this declaration are definitive FOOTPATHS.

3. With reference to 2 above I Richard Langdon Johnson confirm that there are no additional public ways in Nottinghamshire over that part of the land edged in red on the Plan and Statement dated the twentyseventh day of April nineteen hundred and ninety seven.
