

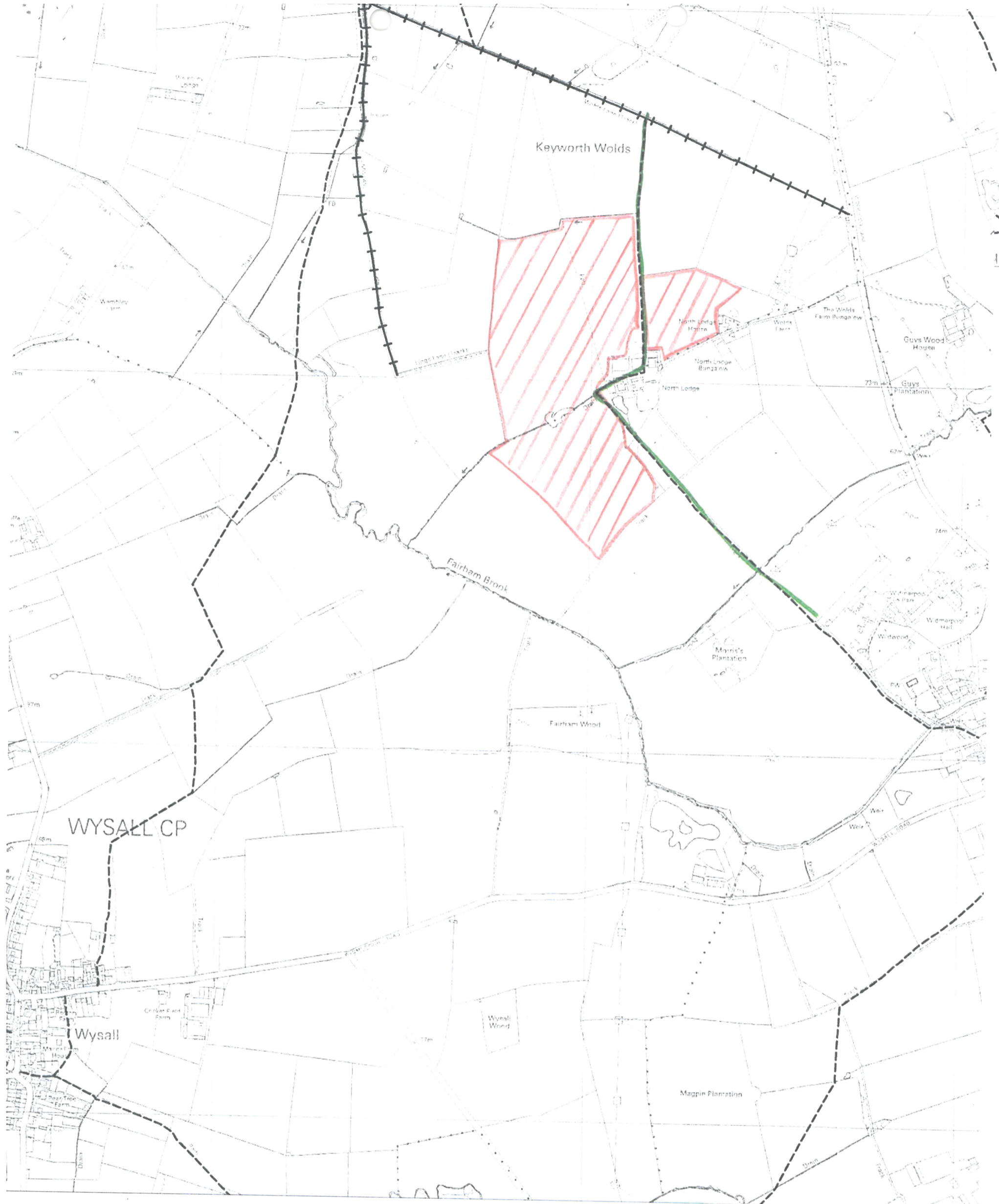

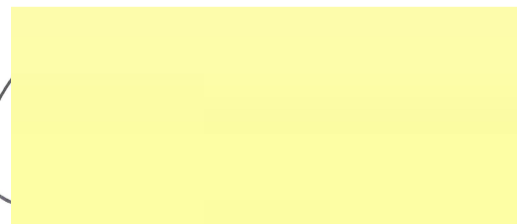

The land outlined and hatched in red on **Map 1** has been owned by The Christopher Butterfield No 2 SIPP since 2 October 2008


The land detailed on the aforementioned maps lies in the Parish/Community of Keyworth



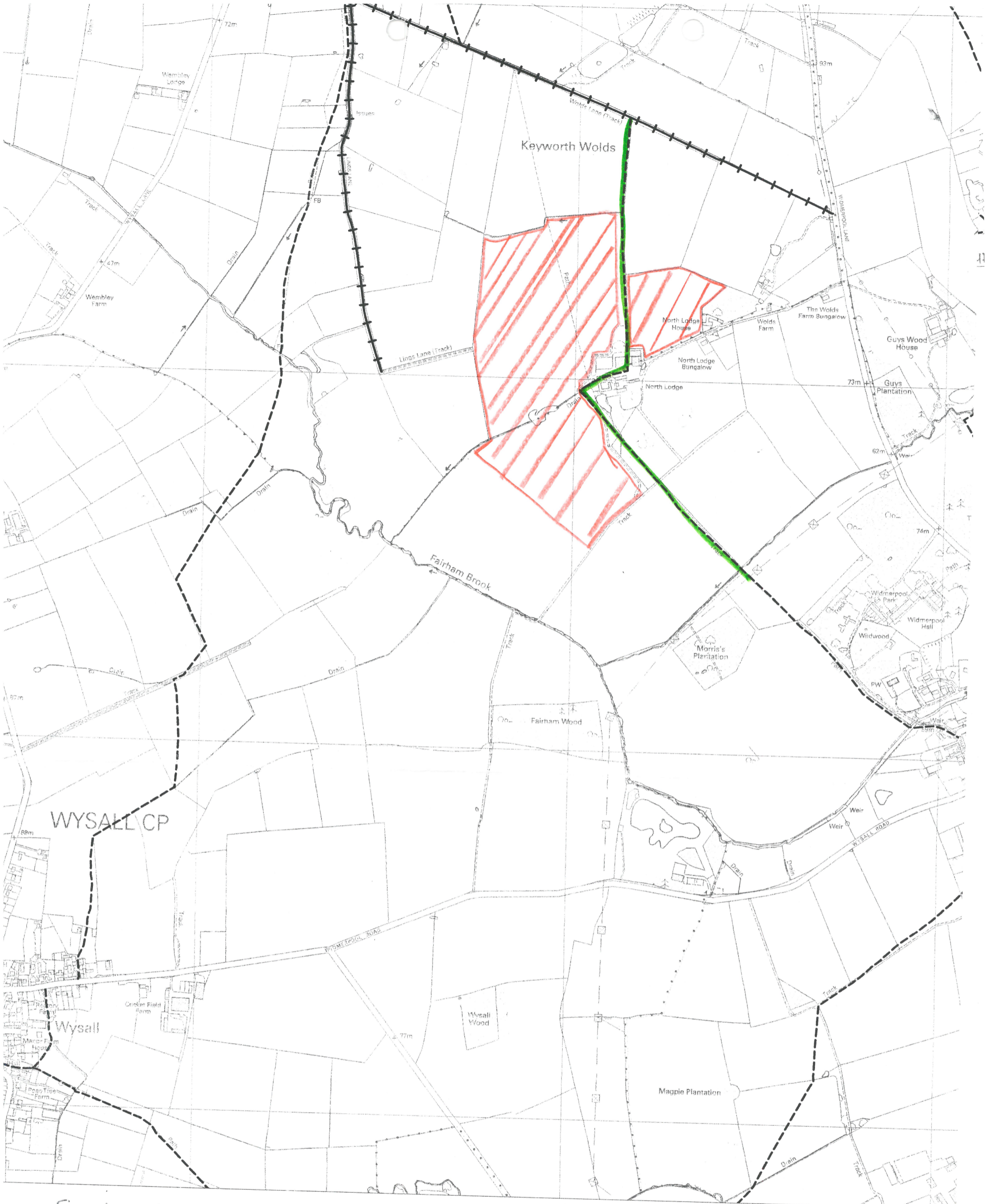
