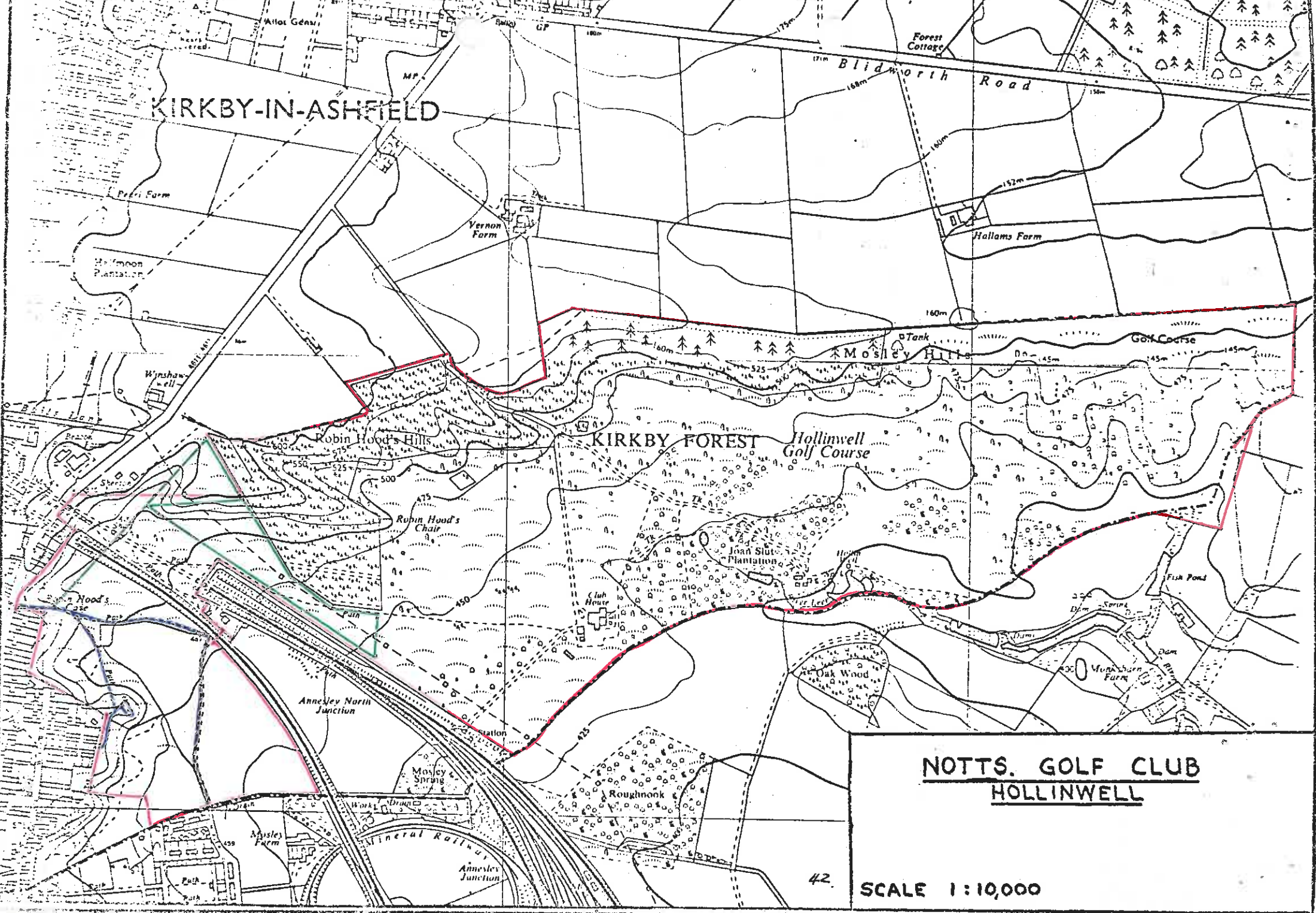

I, John Roscoe Walker of Notts Golf Club Limited Hollinwell Derby Road Kirkby in Ashfield Nottinghamshire do solemnly and sincerely declare as follows:-

1. On the 16th October 1991 our Solicitors Messrs. Fidler & Pepper of Opas House Market Street Sutton in Ashfield Nottinghamshire deposited a map of our land at Hollinwell Derby Road Kirkby in Ashfield Nottinghamshire with the Nottinghamshire County Council together with a statement of the public footpaths dedicated to the public.

2. Since such deposit and statement no footpaths additional to those on such map and described in such statement have been dedicated by me or by the Notts Golf Club Limited for the use of the public as footpaths.

3. There are no other public footpaths whatsoever over the land owned by the Notts. Golf Club Limited.
