

On the twentieth day of March nineteen hundred and ninety seven I deposited with Nottinghamshire County Council being the appropriate Council a statement accompanied by a plan delineating the said land by red edging which stated that the ways coloured purple on the said plan and on the plan accompanying this declaration are definitive or dedicated FOOTPATHS.
