

#### FOOTPATH NO. 2 MANSFIELD

With regard to your memo and enclosure of the 21st July 1981 regarding the above footpath, I would inform you that Mr. Eadson had already been in contact with my Footpaths Officer and also the Ministry of Agriculture on this subject.

Mr. Jones advised Mr. Eadson to write in making the stated declaration in order to protect his field O.S. 249 from further public onslaught other than the registered Footpath No. 2.

From site inspections, it would appear that the "youth groups" from the adjacent housing estate are making inroads in various directions throughout Mr. Eadson's field, trampling his crops in the process.

Mr. Jones has advised him to improve his fencing to try and deter some of the misuse providing that this fencing did not affect the registered path.
