

STATUTORY DECLARATION

SECTION 31(6) OF THE HIGHWAYS ACT 1980

K.H. Bower DO SOLEMNLY AND SINCERELY DECLARE as follows:

- 1. I am and have been since 13th March 1984 the owner of the land known as Long Belt and Cutts Wood/ Beech Hill more particularly delineated on the map accompanying this declaration and thereon edged red.
- 2. On the 2nd day of July I (or my predecessor in title name) deposited with Nottinghamshire County Council , being the appropriate Council , a statement accompanied by a map delineating my property by red edging which stated that (the ways coloured brown on the said map and on the map accompanying this declaration had been dedicated as highways with vehicular status) (the ways coloured green on the said map and on the map accompanying this declaration had been dedicated as bridleways) (the ways coloured purple on the said map and on the map accompanying this declaration had been dedicated as footpath) (no (other) ways had been dedicated as highways over my property) .
- *3. On the day of I (or my predecessor in title name) deposited with Nottinghamshire County Council , being the appropriate Council, a statutory declaration dated stating that no additional ways (other than those marked in the appropriate colour on the map accompanying this declaration) had been dedicated as (highways with vehicular status) (bridleways) (footpaths) since the deposit of the Statement referred to in (2) above.
- 4. No additional ways have been dedicated over the land edged red on the map accompanying this declaration since the statement dated 21st July referred to in (2) above (since the date of the statutory declaration referred to in (3) above) (other than those (highways with vehicular status) (bridleways) (footpaths) marked in the appropriate colour on the map accompanying this declaration) and at the present time I have no intention of dedicating any more public rights of way over my property.

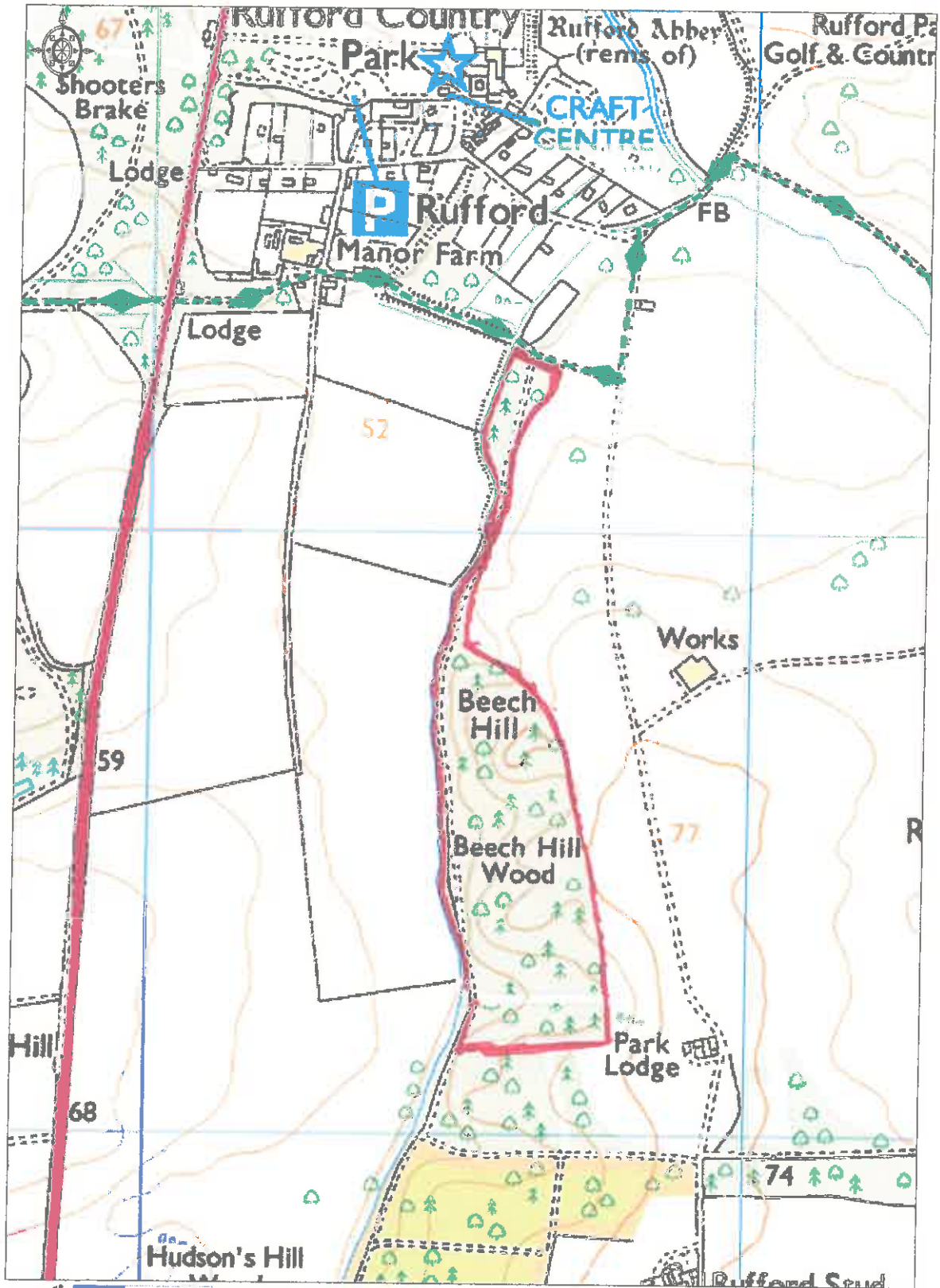

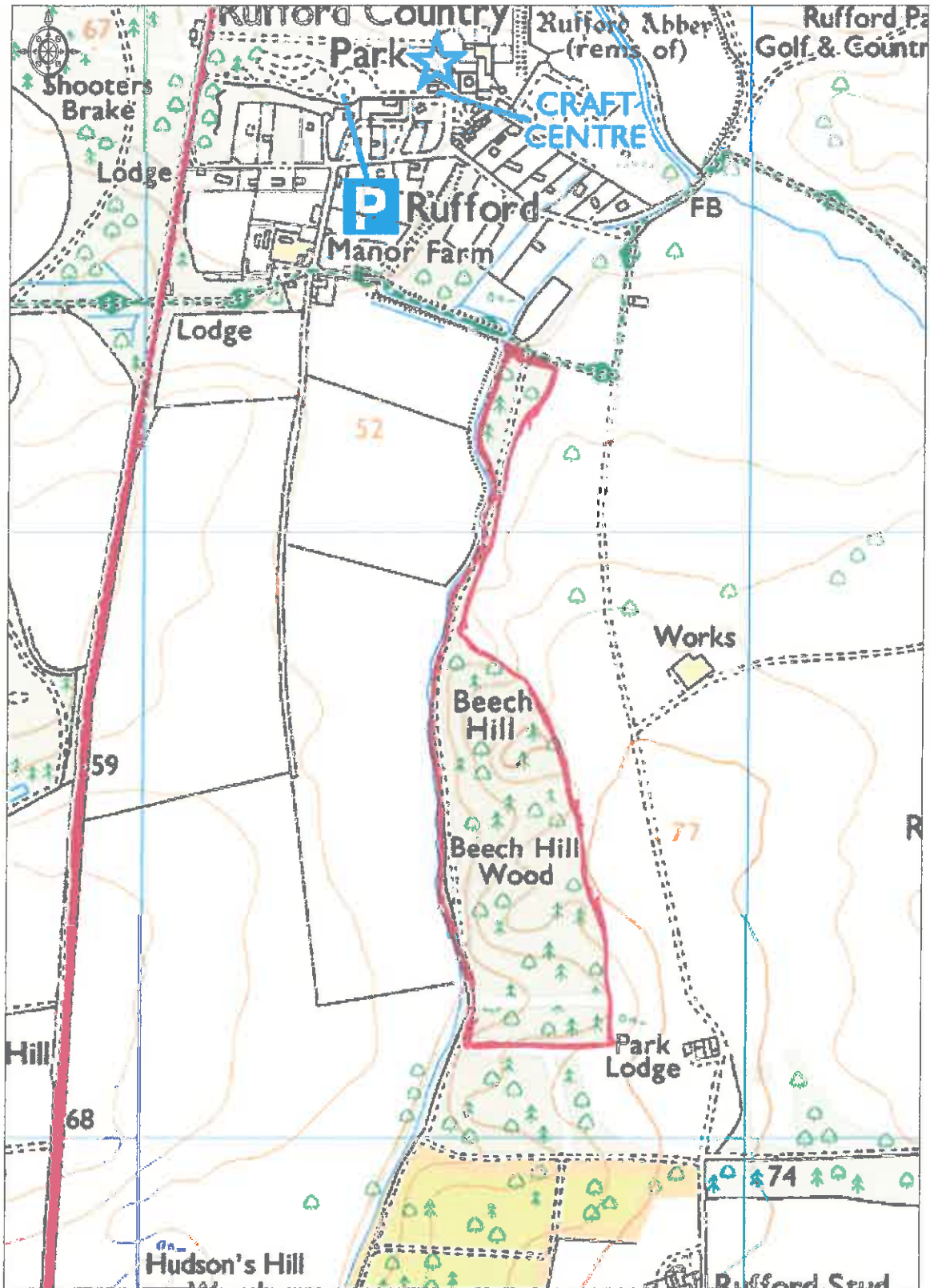
