This is a request under the Freedom of Information Act (FOIA), for details regarding the following:

1. Have rates for sleep-in shifts paid to providers of domiciliary care for young adults under the age of 65 with special needs, or to residential care providers (under 65 or over 65) been amended during the 2017/18 financial year?

Sleep-in rates for providers of Care, Support and Enablement (Supported Living) services increased on 10/4/17 from £70.00 per 9 hour sleep in to £71.83 per 9 hour sleep in.

Rates for residential care providers (under 65 and over 65) were increased on 10/4/17 as follows:

- 2.62% increase on all fees in younger adults care homes
  - 2.8% across older adult banded homes

There was no specific increase applied for sleep-in provision in residential care services.

2. What rates have been agreed and communicated to providers in this regard?

All providers were advised of the uplifts and the rates as follows: <u>Care, Support and Enablement</u> a. Supported living (new packages only) £14.14 per hr and £71.83 per 9 hour sleep-in.

b. Outreach (new packages only) (only for packages under 40 hrs with no shared support and no night time support) - £15.12

c. Supported living plus (new packages only) £16.93 per hour and £71.83 per sleep-in.

Fees relate directly to individual assessment of need and these providers were therefore advised of the 2.62% increase to current packages with no banded rates.
