Thank you for your request for information relating to amount spent on libraries. I can now let you have the following information in response to the questions you raised.

* How many libraries have been closed or cancelled because of cuts to budgets in each year since 2009-10? None

* How many libraries jobs were there in each year since 2009-10?

All libraries remain part of the County Council's responsibility. None are controlled by volunteers. Volunteers are primary service deliverers in 6 libraries in the period 2015/16 to present.
