
Request for Information: Ref NCC-030762-18 A1133 Besthorpe Road, Collingham Road Inspections

Thank you for your request for information relating to road inspections. I can now let you have the following information in response to the questions you raised.

Please provide the following information in relation to the A1133 Besthorpe Road, and in particular the section between Church Lane, Besthorpe and Low Street, Collingham:

This road length is divided up into separate street sections. Section specific Hierarchy and Inspection frequencies:

C.	Besthorpe Road, Besthorpe Inspection Frequency - Monthly	Hierarchy 3a – Main Distributor FW Inspection Frequency – Annual	CW
