Deprivation fund

- 1. Who is it for?
- 2. 2, 3 and 4 year olds know to Children's Social Care, ie Children in Need (CIN) or on a Child Protection Plan (CPP)
- 2. How much is it? £406 per year
- 3. What it is it for?

Additional payment made to support providers to attend monthly multiagency meetings to contribute to a plan and be informed to make good interventions to improve outcomes for eligible children.

Early Years Inclusion Fund Update

- New application / review paperwork to be used now
- New criteria to be used from April

Who is it for?

- 2,3 and 4 year old Nottinghamshire resident children for the hours that they are funded
- Applications for equipment and advice for physical disability will come through this panel too

Panel Dates

All applications need to be received one week before this date

- 26th February 2018
 - 26th March 2018

- 26th April 2018
- 25th June 2018

Disability Access Fund

The setting applies for the DAF on behalf of the parent. They need to do the following:

- 1) Complete the Parent Declaration form section 4. This form needs completing for ALL funded children (whether they are claiming 3 or 4 year funded entitlement). Ensure section 4 is completed
- 2) The parent needs to supply evidence of their DLA (Disability Living Allowance) to the setting
- 3) The setting then submits their Parent Declaration and DLA evidence to Early Childhood Services eypp@nottscc.gov.uk

Universal Credit

- For Early Years Pupil Premium
 - amending existing regulations to implement a net earnings
 threshold of £7,400, to come into force from 1st April 2018
- For the two-year-old entitlement
 - amending regulations to implement a net earnings threshold of £15,400, to come into force from 1 April 2018.

Provider Agreement 2018-19

- New PA effective from April 2018
- MUST BE RETURNED BY SET DATE OTHERWISE FUNDING WILL NOT BE PAID IN SEPTEMBER
- Proposed changes/ updates
 - Compliance regarding use of Supplementary Funding
 - Consent to share data
 - Contact Information
 - Notice Periods
 - GDPR (General Data Protection Regulations)
 - *AUDIT process reviewed to reflect the changes

30 HOURS

30 Hours Take-up

 5575 children have had codes that are valid for the spring term confirmed as eligible on the provider portal.

Of these **5575** children;

- **5325** (95.5%) are using all, or part of their 30 hour entitlement in a Nottinghamshire setting, across **670** different providers.
- 87% of funded childminders, 94% of day nurseries, preschools and independent schools, and 61% of school nurseries are delivering part of the entitlement
- 921 (16.5%) are sharing their funding across 2, or more, settings.

30 HOURS -National messages

- Over 216,000 children were given codes for 30 hours free childcare for Autumn
- One million people have used the HMRC calculator to check what help they could get with childcare.
- HMRC have confirmed that 325,000 codes have been issued for the Spring term which demonstrates just how popular 30 hours continues to be with parents
- No reports of eligible parents unable to access a 30 hour place

Delivery Support Fund

- Up to £70,000 additional funding to help create places needed in hotspot areas for summer term!
- Tight timescales approval March, delivery April-August
- Childminder engagement
- Partnership Hub development
- SEND support

DATA SYSTEMS

- 'Must have'/key documents: you need to refer to these documents to operate effectively:
- Timetable of funded weeks: tells you when tasks open and close and the payment dates. If you miss submitting a task you don't get paid.
- Parent declaration form: collects all the data you need from parents for your headcount return.
- Capita portal instructions: includes how to do a headcount, attach 30 hours codes to children etc.

- 30 hours codes: Updated provider flow chart
- In autumn term, providers were very good at ensuring that majority of parents wishing to access extended entitlement had provided them with their codes etc.
- End of autumn/spring, we issued various reports to warn providers that
 parents were about to fall out of eligibility, but we've had many queries from
 providers and parents about dates on eligible codes.
- Ultimately for us as LA and for you as providers, your parents need to be giving you valid codes. We can't resolve issues about invalid codes.

- 30 hours codes
- Check both date of child's 3rd birthday AND the start date of the code – see flowchart – child may start the term after the later of the two dates.
- Continue to encourage your parents to reconfirm their details when they are red or amber on your 30 hours dashboard.
- We will send audit reports twice a term to inform you who is falling out of eligibility to remind them to reconfirm.

- Headcount tasks:
- Summer term initial task to open 19th March 2018 and close on 29th March.
- NON SUBMISSION OF DATA = NO PAYMENT
- Payment date 16th April if data submitted.
- This will be a 30% payment

- Betterstart tasks
- These will continue to be issued mid term for assessments done at any point in the term
- Task closure dates will be

31st March 31st August 31st December
