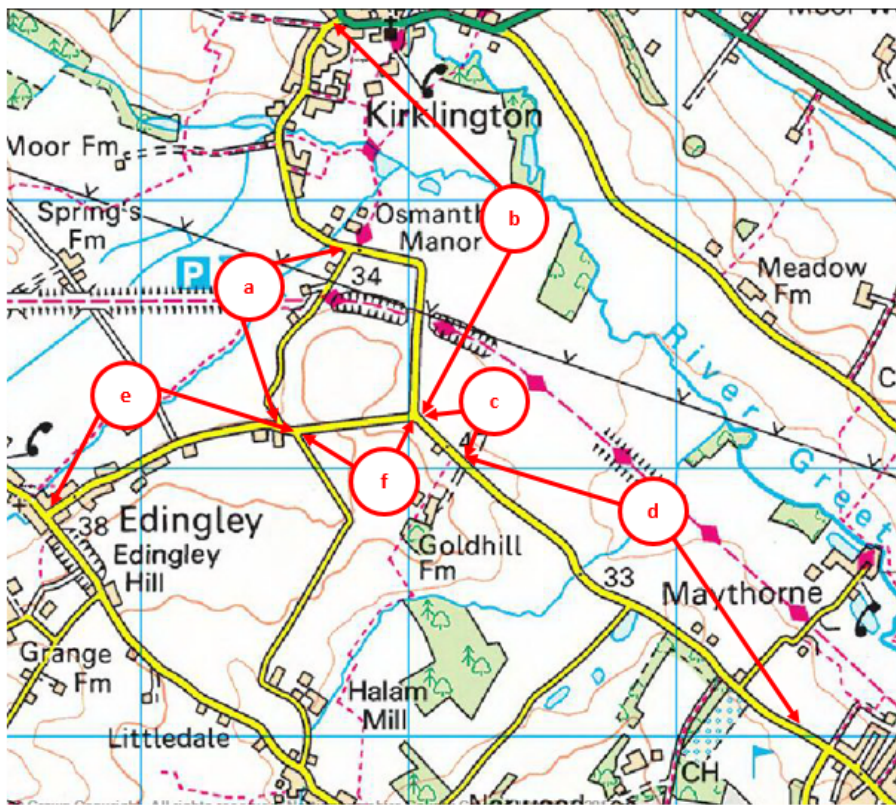


Request for Information: Ref NCC-031146-18

This entry appears to show that the part of the road between the junctions of Southwell Road and Station Road is neither named or maintained by Notts CC, which is clearly incorrect)

Section c and d on plan: Lower Kirlington Road, Edingley and Lower Kirklington Road, Halam respectively

Note: Section c and d were combined up to 27/02/2017 (as Lower Kirklington Road, Halam 26805177) when section c was split/created. Both Street history reports attached.
