 - 4. Are there <u>on-street</u> municipal recycling facilities (e.g. appliance bins) for small appliances in the local authority area?
 - 5. Is there advice available for local residents on recycling appliances on the local authorities website?

Thank you for your recent Freedom of Information Request.

I am now able to provide you with the information supplied by the relevant department, as follows:

- 1. Are there white goods (fridges, washing machines, tumble dryers) recycling facilities in the local authority area?
 - The County Council provides 12 Recycling Centres for residents to deposit white goods, the district councils provide kerbside collection services, with regard to "actual" recycling facilities i.e. DCF's you may wish to consult Valpak or the Environment Agency.
- 2. If yes in what form for white goods a) council collection service b) municipal recycling facility c) both?

Yes both.

3. Are there small appliance (e.g. irons, toasters, kettles) recycling facilities in the local authority area?

The County Council provides 12 Recycling Centres for residents to deposit small appliances. Gedling Borough Council are the only district council offering WEEE banks for small appliances.

- 4. Are there <u>on-street</u> municipal recycling facilities (e.g. appliance bins) for small appliances in the local authority area?
 - Only Gedling Borough Council offer WEEE banks for small appliances.
- 5. Is there advice available for local residents on recycling appliances on the local authorities website?
 - Each individual district council has their own website with advice on recycling. Advice for residents on Nottinghamshire County Council can be found at:
