## Tour Of Britain running costs NCC-033552-18

Under the Freedom if Information Act - Please supply me with all the costs that Nottinghamshire County Council has incurred in supporting the Tour of Britain Cycle Race through the county

Dear Requester,

Further to your recent request for information under the Freedom of information act please see Nottinghamshire County Council response.

With regard to the FOI requesting information as to the breakdown of expenditure by NCC on stage 7 of the TOB, the expenditure incurred does not fall into the categories requested. In total the County Council has spent £195,090.95 and received contributions from district councils totalling £75,000 leaving a net expenditure of £120,090,95.

The majority of the expenditure comprises £160,000 paid to the TOB. As organisers of the event TOB provide all of the security, hospitality, guest travel etc associated with the event. We would not hold any details as to how this contribution was spent. This covers the first 3 categories for which information is requested.

Road closures (notices etc) would be undertaken by existing NCC staff as part of normal duties. The cost of this work is not charged to the event and therefore would not be separately identified.

The remaining NCC expenditure of £35,090.95 was spent on publicity and advertising such as banners, posters ,hats, bookmarks, postcards etc. I have attached a document detailing invoices paid for further info to illustrate this.

The districts has already been submitted. As the hospitality is provided by Tour of Britain, security is provided by ToB and guests travel to the event independently

The request was not specific as to years so I have included information for both 2017 and 2018.
