I am writing to request information under the Freedom of Information Act about applications to schools, made under the exceptional medical or social needs admission (EMSNA) rule. Can you please tell me:

-How many applications did you have for entry to schools this academic year (2018/19), which requested special consideration on the grounds of a child's exceptional medical or social needs. Please break down this information by primary and secondary school. Nottinghamshire County Council is the admission authority for Community and Voluntary Controlled School.

NCC's determined admission arrangements for state

"Special consideration

Nottinghamshire County Council will consider applications for community and voluntary controlled schools where the application can be supported by written evidence from a doctor, social worker or other relevant professional stating why a particular school is the only school which could cater for the child's particular needs. The evidence must be presented at the time of application.

The appropriate designated officers will consider each case and decide the allocation of any such place on the basis of written evidence. Where it is agreed that a particular school is the only school that could meet a child's needs, the application will have priority following the allocation of looked after and previously looked after children."

NCC received 33 on time applications for first admission to school in September 2018 (reception year group) with evidence submitted by the applicant at the time of application. NCC is not the admission authority for any secondary schools.

-How many applications on these grounds you received for each of the four preceding academic years (2014/15, 2015/16, 2016/17, 2017/18)

NCC received 62 on time applications for first admission to school in September 2017 (reception year group) with evidence submitted by the applicant at the time of application. NCC does not hold information on the number of applications received in previous years.

-How many applications on these grounds were successful each year

NCC holds records of the number of applications where priority was given in the oversubscription criteria for applications in the academic year. 2018/19 school year to date – 6 on time applications for first admission to school (6 of the 33 on time applications referred to above) 2017/18 3 on time applications for first admission to school (3 of the 62 on time applications referred to above) 1 application to secondary school (information received after the application had been processed) 2 in year applications 2016/17 7 on time applications for first admission to school with evidence submitted by the applicant at the time of application 9 applications for first admission to school with evidence submitted by the applicant after the national offer day 2 in year applications
