(Including School Admissions, Free School Meals, Fair Access and Elective Home Education)

Introduction

This privacy notice explains how the Council uses your data to allocate school places, assess entitlement to free school meals, identify appropriate education provision.

Who will be using your data?

Nottinghamshire County Council will be the data controller for the data you provide to us.

We may also contract third party organisations to process your data on our behalf.

What legal reasons allow us to use your data in this way?

Our legal basis for processing your personal data is to that it is necessary to perform our public tasks as a local authority.

Our legal basis for processing your special category personal data is that it is for reasons of substantial public interest.

Our legal basis for processing data about criminal convictions, criminal offences or related security measures is that it is necessary to perform our public tasks as a local authority.
